The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is considering a Basin Plan amendment to incorporate Total Maximum Daily Loads (TMDLs) for chlordane, polycyclic aromatic hydrocarbons (PAHs), and polychlorinated biphenyls (PCBs) in sediment at the mouths of Paleta, Chollas, and Switzer creeks in San Diego Bay. This action is being proposed to meet requirements of section 303(d) of the federal Clean Water Act. Additionally, the San Diego Water Board is considering miscellaneous changes to Chapter 5 to update the list of Regional Board Resolutions. The Basin Plan amendment process is authorized under section 13240 of the California Water Code.

FILING OF ENVIRONMENTAL DOCUMENTS

The San Diego Water Board is proposing to adopt or amend the proposed Basin Plan amendment in accordance with a certified regulatory program exempt under section 21080.5 of the Public Resources Code from the requirement to prepare an environmental impact report under the California Environmental Quality Act (CEQA) [Public Resources Code section 21000 et seq.] and with other applicable laws and regulations.

PUBLIC HEARING

The San Diego Water Board will hold a public hearing on June 12, 2013 to deliberate and consider adoption of the proposed Basin Plan amendment to incorporate TMDLs for toxic pollutants in sediment at the mouths of Paleta, Chollas, and Switzer creeks in San Diego Bay. The meeting will begin at 9:00 a.m.
