NOTICE OF PUBLIC HEARING AND WRITTEN COMMNET PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2017-0102, *An Order Rescinding Orders Nos 94-46 and 94-142* (Tentative Order) for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **October 11**, **2017**. The Tentative Order, if adopted, will rescind:

- Order No. 94-46, Waste Discharge Requirements for the County of Orange General Services Agency, Los Piños Forestry Camp, Orange County; and
- Order No. 94-142, Waste Discharge Requirements for Barrett Lake Mobile Home Park, San Diego County.

Background

The Tentative Order, if adopted, would rescind Waste Discharge Requirements (WDRs) for the Los Piños Forestry Camp and Barrett Lake Mobile Home Park. The discharges from the onsite wastewater treatment systems located at each of the facilities will be enrolled in State Water Resources Control Board Order No. WQ 2014-0153-DWQ, General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems.¹

The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Wednesday, September 13, 2017**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
