Mr. Northcote:

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) has reviewed the following self-monitoring reports (SMRs) for the aforementioned facility:

- Monthly SMRs October 2016 through November 2016
- Quarterly SMR October 2016 through December 2016

The following is a summary of the San Diego Water Board's findings:

1. Violation - Effluent Exceedances, Section IV.A, Table 4

On December 5, 2016, discharges from Monitoring Location No. EFF-001A exceeded the average monthly effluent limitation (AMEL) for chronic toxicity. The AMEL for chronic toxicity is exceeded and a violation is flagged when a chronic toxicity test, analyzed using the Test of Significant Toxicity (TST) statistical approach, results in "Fail."

Pursuant to the California Water Code (CWC), the violations noted are subject to additional enforcement action(s) by the San Diego Water Board including a time schedule order, cease and desist order, cleanup and abatement order, imposition of administrative civil liability, referral to the district attorney for criminal prosecution, or referral to the attorney general. Administrative civil liability amounts that may be imposed by the San Diego Water Board under authority of CWC section 13385 include up to \$10,000 per day, or up to \$10 per gallon for each gallon of waste discharged.
