The Building Industry Coalition gave their presentation, after which they answered the Board members' questions.

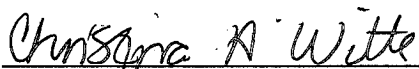
*Mr. Morales called a recess at 6:15 p.m. and reconvened the meeting at 6:25 p.m.*
