REGIONAL BOARD RESOLUTION NO. 89-33

INCORPORATION OF "SOURCES OF DRINKING WATER" POLICY INTO THE WATER QUALITY CONTROL PLAN (BASIN PLAN) OF THE SAN DIEGO REGION

WHEREAS:

- 1. California Water Code Section 13140 provides that the State Water Resources Control Board (State Board) shall formulate and adopt State policy for water quality control; and,
- California Water Code Section 13240 provides that Basin Plans shall conform to any State policy for water quality control; and,
- 3. The State Board adopted Resolution No. 88-63 entitled "Sources of Drinking Water" on May 19, 1988 as a State policy for water quality control; and,
- 4. Previous to passage of State Board Resolution 88-63, two public workshops on Jaunary 6, 1988 and April 6, 1988 and a public hearing on May 4, 1988 were conducted in order to receive comments on the Policy; and,
- 5. The San Diego Regional Water Quality Control Board (Regional Board) adopted Resolution No. 88-25 on March 14, 1988, in support of the State Board's policy in its entirety; and,
- 6. Incorporation of State Board Resolution No. 88-63 into the Comprehensive Water Quality Control Plan for the San Diego Region (Basin Plan), will conform this Basin Plan to this Policy; and,
- 7. The basin planning process has been determined to be functionally equivalent to the CEQA process in accordance with Section 21000 et seq. of the Public Resources Code and appropriate notices and waiting periods have been complied with.

THEREFORE BE IT RESOLVED THAT:

1. The Basin Plan's Chapter 2 entitled <u>Beneficial Uses</u> be amended to include the following statement:

"Water bodies within the Region that do not have beneficial uses designated for them in Tables 2-1, 2-2, and 2-3 are assigned Municipal and Domestic Supply (MUN) designations in accordance with the provisions of State Water Resources Control Board Resolution No. 88-63 which is, by reference, a part of this plan. These MUN designations in no way affect the presence or absence of other beneficial use designations in these water bodies.

A list of water bodies the Regional Board had previously determined <u>not</u> to support the MUN designation is attached as Table A."

- 2. Table 2-1 of the Basin Plan is amended to include a MUN designation to the Paradise ground water Hydrographic Subunit (8.30). The applicable water quality objectives will be determined thru a ground water assessment and inserted into the Basin Plan.
- A copy of this resolution with other appropriate materials be submitted to the State Board for approval.

In addition, a Basin Plan amendment (Resolution No. 78-6) adopted by the Regional Board on February 27, 1978, deleted beneficial use designations including municipal and domestic supply in portions of the following groundwater basins where available information indicated the beneficial uses did not occur and were not likely to occur in the future:

- 1. Westerly of the easterly boundary of the right-of-way of Interstate Highway 5 in Hydrographic areas 1.13 (Aliso); 1.30 (San Clemente); 1.40 (San Mateo); 1.51 (San Onofre); 1.52 (Las Pulgas); 1.53 (Stuart); 2.11 (Ysidora); 3.11 (Mission); 4.21 (Carlsbad); 4.31 (Agua Hedionda); 4.51 (Batiquitos); 4.61 (San Elijo); 5.11 (San Dieguito); 6.10 (Soledad); 7.11 (Mission San Diego);
- 2. All lands on the coastal side of the inland boundary of the right-of-way of the Pacific Coast Highway in Hydrographic areas 1.11 (San Joaquin) and 1.12 (Laguna).
- 3. All lands on the coastal side of the inland boundary of the right-of-way of the Pacific Coast Highway west of the San Juan Creek channel in Hydrographic area 1.20 (San Juan).
- 4. Hydrographic areas 4.51 (Batiquitos) and 4.52 (San Marcos) between Highway 78 and El Camino Real and to all lands which drain to Moonlight Creek and Encinitas Creek.
- 5. Hydrographic area 6.10 (Soledad) to all lands which drain to Los Penaquitos Canyon from 1.5 miles west of Interstate Highway 15.
- 6. Hydrographic area 11.10 (Tijuana) west of Hollister Street.
