SAN DIEGO COUNTY**

The California Regional Water Quality Control Board, San Diego Region (Regional Board) finds that:


1. Order No. 86-48 as amended prescribes waste discharge requirements to Eldon and Dian Cornette for discharge of domestic wastewater via a septic tank/percolation pond system at Pinecrest Park located at 3936 Highway 78, Julian, California.
2. The Regional Board was notified on December 19, 2006 that the transfer of ownership of Pinecrest Park from Eldon and Dian Cornette to Kathleen Rosenow and Frank Spevancelc occurred on December 7, 2005.
3. This Order, which enforces the laws and regulations administered by the Regional Board, involves the permitting of an existing facility and does not involve expansion beyond that existing at the time of adoption of this Order. This Order therefore is categorically exempt from the California Environmental Quality Act (CEQA) (Public Resources Code section 21000, *et seq.*) pursuant to California Code of Regulations, Title 14, Chapter 3, Article 19, section 15301.
5. This Regional Board has notified the new owners and all known interested persons of the intent to issue an amendment to Order No. 86-48
6. This Regional Board in a public meeting has heard and considered all comments pertaining to the proposed amendment.

IT IS HEREBY ORDERED, that:

1. Order No. 86-48 shall henceforth be titled *Waste Discharge Requirements for Kathleen Rosenow and Frank Spevancelc, Pinecrest Park, San Diego County*.
2. The waste discharge requirements contained in Order No. 86-48 shall be the responsibility of Kathleen Rosenow and Frank Spevancelc.

3. The term "Discharger" as it appears in Order No. 86-48 shall hereinafter refer to Kathleen Rosenow and Frank Spevacek.
4. Eldon and Dian Cornette are liable for violations of Order No. 86-48 prior to December 7, 2005 and Kathleen Rosenow and Frank Spevacek are liable for violations of Order No. 86-48 from December 7, 2005 forward.
