ADDENDUM NUMBER 1 TO CLEANUP AND ABATEMENT ORDER NO. 2000-255

On November 7, 2000, the California Regional Water Quality Control Board, San Diego Region (Regional Board) issued Cleanup and Abatement Order No. 2000-255 to you for the Budget Trade and Gas facility in Escondido. Cleanup and Abatement Order No. 2000-255 (order) is hereby amended as follows.

Section II of the order, entitled "Site Investigation Report" is replaced with the following section:

II. FULLY DELINEATE SOIL AND GROUNDWATER CONTAMINATION

The dischargers shall fully delineate the extent of soil and groundwater contamination caused by discharges of petroleum waste, vertically and horizontally, on-site and off-site and submit to this office a site investigation report that documents and describes the full delineation of soil and groundwater petroleum contamination vertically and horizontally, on-site and off-site by March 22, 2001.

Section II is replaced because, as originally written, it required submission of a site investigation workplan. However, a site investigation workplan, dated March 8, 2000, was received by this office.

Section III of the order, entitled "Corrective Action Plan" is deleted. This section is not necessary as you are required to submit a corrective action plan pursuant to California Water Code section 13267 as described in letters dated June 9, 1999, and September 29, 2000. You are currently in violation of the Regional Board's request for this report, as reflected by Administrative Civil Liability Order No. 2000-23, assessing civil liability of \$35,680 for failure to submit the report, and Complaint No. 2000-256 for your continued failure to submit the report.
