ORDER NO. R9-2019-0079

**AN ORDER RESCINDING ORDER NO. 94-109
WASTE DISCHARGE REQUIREMENTS FOR SAN DIEGO COUNTY,
LOWER OTAY LAKE COUNTY PARK, SAN DIEGO COUNTY**

The California Regional Water Quality Control Board, San Diego Region, (hereinafter San Diego Water Board), finds that:

1. Order No. 94-109, *Waste Discharge Requirements for San Diego County, Lower Otay Lake County Park, San Diego County* (Order No. 94-109), established requirements for the subsurface disposal of domestic wastewater through three septic tanks and three leach fields located at 2270 Wueste Road in Chula Vista. The San Diego Water Board adopted Order No. 94-109 on September 8, 1994.
2. The State Water Resources Control Board adopted the *Water Quality Control Policy for Siting, Design, Operation, and Maintenance of Onsite Wastewater Treatment Systems* (OWTS Policy), which allows local agencies to approve onsite wastewater treatment systems (OWTS), based on a local ordinance, after approval of the Local Agency Management Plan for Onsite Wastewater Treatment Systems (LAMP) by the Regional Water Quality Control Board. The purpose of the LAMP is to allow the continued use of OWTS within the jurisdiction of the local agencies, as well as to expand the local program to permit and regulate alternative OWTS while protecting water quality and public health. The County of San Diego Department of Environmental Health (County of San Diego) LAMP was approved by the San Diego Water Board on February 24, 2015.
3. The San Diego Water Board inspected the Lower Otay Lake County Park onsite wastewater treatment system (Facility) on January 7, 2019. The San Diego Water Board confirmed the eligibility of the Facility to enroll in the County of San Diego LAMP.
4. The County of San Diego notified the San Diego Water Board on February 14, 2019, that the Facility is eligible for regulatory oversight under the LAMP.
5. The San Diego Water Board heard and considered all comments pertaining to the adoption of Order No. R9-2019-0079, in a public meeting on June 12, 2019.
6. Order No. R9-2019-0079 rescinds Order No. 94-109. Pursuant to the title 14, California Code of Regulations, section 15301, the project is exempted from the California Environmental Quality Act because adoption of Order No. R9-2019-0079 will not involve expansion or modification of the existing facility. Adoption of Order No. R9-2019-0079 will not have any significant impact on the environment.

IT IS HEREBY ORDERED that Order No. 94-109 is rescinded.
