ORDER NO. R9-2020-0137

**AN ORDER RESCINDING ORDER NO. 94-150, WASTE DISCHARGE
REQUIREMENTS FOR MR. KIM EGGLESTON, RANCHO CORRIDO
RECREATIONAL VEHICLE PARK, SAN DIEGO COUNTY**

The California Regional Water Quality Control Board, San Diego Region (hereinafter San Diego Water Board) finds that:

1. Order No. 94-150, *Waste Discharge Requirements for Pauma Valley Investment Trust, Rancho Corrido Trailer Park, San Diego County* (Order No. 94-150) , established requirements for the discharge of domestic wastewater from an Onsite Wastewater Treatment System (OWTS), which consists of eight septic tanks, a leach field, and a horizontal seepage pit. Domestic wastewater from the Facility is collected from approximately 120 sewer connected recreational vehicle spaces, restrooms, laundry facilities, a store and an impervious dump station and discharged to a subsurface disposal system. Addendum No. 1 to Order No. 94-150, *An Addendum Transferring Responsibility for Order No. 94-150 to Mr. Kim Eggleston* (Addendum No. 1), modified Order No. 94-150 transferring responsibility for complying with the established waste discharge requirements to Mr. Kim Eggleston. The Rancho Corrido Recreational Vehicle Park is located 14715 Highway 76, Pauma Valley in San Diego County. The San Diego Water Board adopted Order No. 94-150 on November 10, 1994 and Addendum No. 1 on August 14, 2013.
2. Order No. 94-150 and Addendum No. 1 must be replaced to ensure that the discharge is regulated consistent with current State policy and requirements. Discharge from small OWTS such as these have certain common characteristics, such as similar constituents, concentrations of constituents, disposal techniques, flow ranges, and they require the same or similar treatment standards. The State Water Resources Control Board issued Order WQ 2014-0153-DWQ, *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems* (General Order) to regulate these types of discharges consistently throughout the State.
3. The discharge from the Rancho Corrido Recreational Vehicle Park OWTS is eligible for enrollment in the General Order based on information provided in monitoring reports and information obtained during a compliance inspection conducted by San Diego Water Board staff on December 14, 2018. The discharge from Rancho Corrido Recreational Vehicle Park OWTS is eligible for enrollment in the General Order based on information provided in monitoring reports and the ROWD submitted to the San Diego Water Board on October 14, 2017. As such, the discharge from the Rancho Corrido Recreational Vehicle

Park OWTS is more appropriately regulated under the General Order than individual waste discharge requirements (WDRs).

4. The San Diego Water Board will issue a Notice of Applicability (NOA) to the Rancho Corrido Recreational Vehicle Park for enrollment in the General Order prior to the board meeting on August 12, 2020. The NOA's effective date of enrollment in the General Order coincides with the adoption date of this rescission Order.
5. Adoption of Order No. R9-2020-0137 is exempt from the California Environmental Quality Act (CEQA) pursuant to California Code of Regulations, title 14 (title 14), section 15061(b)(3) because it can be seen with certainty that there is no possibility that rescission of WDRs for Rancho Corrido Recreational Vehicle Park may have a significant effect on the environment and is therefore not subject to CEQA. In addition, adoption of this Order is exempt from CEQA pursuant to categorical exemptions at title 14, section 15301 (ongoing or existing projects), section 15302 (replacement or reconstruction of existing utility systems), and section 15303 (new construction or conversion of small structures). Finally, activities at this facility will be covered under the General Order which was adopted in compliance with CEQA.
6. The San Diego Water Board heard and considered all comments pertaining to the adoption of Order No. R9-2020-0137 in a public meeting.

IT IS HEREBY ORDERED that Order No. R9-2020-0137 is adopted.
