R9-2021-0100, Total Organic Carbon Effluent Monitoring

Lindsay Leahy:

This letter serves to inform the City of Oceanside (City) that the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), modified Attachment E - Monitoring and Reporting Program (MRP) of Order No. R9-2021-0100, Waste Discharge and Water Reclamation Requirements for the City of Oceanside, Advanced Water Purification Facility, Indirect Potable Reuse for Groundwater Recharge, San Diego County (Order No. R9-2021-0100). The San Diego Water Board modified the MRP based on recommendations received from the State Water Resources Control Board's Division of Drinking Water (DDW) on December 2, 2022. The San Diego Water Board's actions, and DDW's recommendations, are consistent with California Code of Regulations (CCR) title 22, division 4, section 60320.218(a). Attachment A of this letter provides the City with the revised Table E-3 of the MRP. Revisions to Table E-3 are indicated in underline-strikethrough format.

DDW recommended that the San Diego Water Board revise the MRP to allow the City to collect grab samples, instead of composite samples, at effluent monitoring location M-008 for total organic carbon (TOC). DDW's recommendation letter explained that DDW approved the City's request to collect grab samples for TOC at monitoring location M-008, on November 22, 2022.
