NOTICE OF PUBLIC WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), is releasing Tentative Addendum No. 1 to Order No. R9-2021-0020, *Waste Discharge Requirements for Lennar Homes California LLC, Horizons/Approved Tract Map Riverside County* (Order No. R9-2021-0020) (Tentative Addendum), for public review and comment. The Tentative Addendum, if adopted, will amend *Order No. R9-2021-0020, Waste Discharge Requirements for Strata Keith LLC, Horizons/Approved Tract Map No. 36672 Project, Riverside County* to reflect a change in ownership.

Submission of Written Comments

Notice is hereby given that the San Diego Water Board will accept written comments regarding the Tentative Addendum in accordance with this notice.

The written comment period provides an opportunity for interested persons to comment on the Tentative Addendum. All written comments regarding the Tentative Addendum must be received no later than **5:00 p.m. on November 20, 2025**, to be considered by the San Diego Water Board. Written comments sent by mail must be addressed to California Regional Water Quality Control Board – San Diego Region, 2375 Northside Drive, Suite 100, San Diego, California 92108-2700, and ATTN: Eric Becker. Comments can also be submitted by e-mail to sandiego@waterboards.ca.gov. The subject line of all written comments must include “Comment – Tentative Addendum 1 to Order No. R9-2021-0020.”

The early submission of written comments on the Tentative Addendum is encouraged. Written comments received by **5:00 p.m. on November 20, 2025**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider the adoption of the Tentative Addendum. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on November 20, 2025**, will not be accepted

and will not be incorporated into the administrative record if doing so would prejudice any party.

Public Hearing for Consideration of the Tentative Addendum

The San Diego Water Board will publish a *Meeting Notice and Agenda* in advance of the public hearing for the Tentative Addendum. The *Meeting Notice and Agenda* will indicate the meeting date, time, location, and may provide other specific information concerning this hearing.
