The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), is releasing Tentative Cleanup and Abatement Order No. R9-2023-0102, An Order Directing Citizens Development Corporation, Symphony Asset Pool XXI LLC, LSM Golf Course Partners LLC, Hollandia Dairy Inc., Wilgenburg Dairy, City of San Marcos, City of Escondido, Vallecitos Water District, and County of San Diego to Clean Up or Abate Effects of Waste Discharged to Lake San Marcos and San Marcos Creek, San Diego County (Tentative CAO), for public review and comment. The San Diego Water Board will consider adoption of the Tentative CAO at its regularly scheduled meeting on March 13, 2024.

Written comments received by **5:00 p.m. on Friday, November 3, 2023**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative CAO. The Board staff may prepare written responses to comments or instead choose to summarize comments and suggested modifications at the March 13, 2024, meeting. Consistent

with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Friday, November 3, 2023**, may not be accepted and may not be incorporated into the administrative record if doing so would prejudice any party, at the Board Chair's discretion.
