Settlement Offer No. R9-2025-0146 Related to Violations of Order No. R9-2017-0007 as Amended, National Pollutant Discharge Elimination System No. CA0107409 for City of San Diego, E.W. Blom Point Loma Wastewater Treatment Plant, San Diego, CA 92106, Discharge to the Pacific Ocean Through the Point Loma Ocean Outfall

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing, for public review and comment, Settlement Offer No. R9-2025-0146 Related to Violations of Order No. R9-2017-0007 as Amended, National Pollutant Discharge Elimination System No. CA0107409 for City of San Diego, E.W. Blom Point Loma Wastewater Treatment Plant, San Diego, CA 92106, Discharge to the Pacific Ocean Through the Point Loma Ocean Outfall (Settlement Offer). The Settlement Offer is an agreement between City of San Diego (Discharger) and the San Diego Water Board to address alleged violations of Order No. R9-2017-0007 as Amended¹, NPDES No. CA0107409, Waste Discharge Requirements and National Pollutant Discharge Elimination System Permit for the City of San Diego E.W. Blom Point Loma Wastewater Treatment Plant Discharge to the Pacific Ocean Through the Point Loma Ocean Outfall. To resolve the alleged violation without formal administrative proceedings, the Discharger has agreed to pay the mandatory minimum penalty related to alleged violation in the amount of \$3,000.
