### **NOTICE OF WRITTEN COMMENT PERIOD FOR SETTLEMENT OFFER NO. R9-2026-0016 RELATED TO VIOLATIONS OF ORDER NO. R9-2019-0003 AS AMENDED, NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM NO. CA0109223 FOR CHANNELSIDE WATER RESOURCES LP, CLAUDE "BUD" LEWIS CARLSBAD DESALINATION PLANT, CARLSBAD, CA 92008, DISCHARGE TO THE PACIFIC OCEAN**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing, for public review and comment, Settlement Offer No. R9-2026-0016 *Related to Violations of Order No. R9-2019-0003 as amended, National Pollutant Discharge Elimination System No. CA0109223 for Channelside Water Resources LP, Claude "Bud" Lewis Carlsbad Desalination Plant, Carlsbad, CA 92008, Discharge to the Pacific Ocean* (Settlement Offer). The Settlement Offer is an agreement between Channelside Water Resources LP (Discharger) and the San Diego Water Board to address alleged violations of Order No. R9-2019-0003, as amended by Orders No. R9-2020-0004 and No. R9-2023-0137, NPDES No. CA0109223, *Waste Discharge Requirements for the Poseidon Resources (Channelside) LP Claude "Bud" Lewis Carlsbad Desalination Plant Discharge to the Pacific Ocean*. (Order). To resolve the alleged violations without formal administrative proceedings, the Discharger has agreed to pay the mandatory minimum penalties related to alleged violations in the amount of \$3,000.
