**NOTICE OF WRITTEN COMMENT PERIOD**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2026-0025, *Waste Discharge Requirements for Tri Pointe Homes, Nakano Project, San Diego County* (Tentative Order) for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **March 11, 2026**.

The San Diego Water Board is considering adoption of the Tentative Order in response to a Report of Waste Discharge (ROWD) application submitted by Tri Pointe Homes (Discharger) for the discharge of permanent fill material to 0.40 acre (649 linear feet) of wetland waters of the State from the Nakano Project (Project). The Project is located within the City of Chula Vista, San Diego County, California northwest of Dennerly Road, San Diego, California 92154.

The Tentative Order authorizes unavoidable direct impacts by the Project to wetland waters and requires the Discharger to implement compensatory mitigation sufficient to offset the permanent impacts. The Discharger proposes to develop residential housing consisting of detached condominiums, duplexes, and townhome dwelling units. The Project includes construction of a primary access road, internal private streets and driveways, a secondary emergency access road, pocket parks, trail connections to Otay Valley Regional Park, two pipe culverts, a concrete box culvert, two biofiltration basins and a modular wetland with a detention vault. Additionally, water and wastewater services would be provided by extending and reconstructing existing water and sewer lines. Under the terms of the Tentative Order, the Discharger was required to demonstrate that replacement of the full range of lost aquatic resource(s) and/or functions through compensatory mitigation will be provided in perpetuity. Thus, the Tentative Order will authorize the Discharger to proceed with the Project subject to the conditions of the Tentative Order.

The written comment period provides an opportunity for interested people to comment on the Tentative Order. All written comments regarding the Tentative Order must be received **no later than 5:00 p.m. on Friday, February 27, 2026**, to be considered by the San Diego Water Board. The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Friday, February 27, 2026**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider the adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Friday, February 27, 2026**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

### **Public Hearing for Consideration of Tentative Order Adoption**

The San Diego Water Board will publish a *Meeting Notice and Agenda* in advance of the public hearing for the Tentative Order. The *Meeting Notice and Agenda* will indicate the meeting date, time, location, and may provide other specific information concerning this hearing.
