### **BASIN PLAN AMENDMENT**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is considering an amendment to the *Water Quality Control Plan for the San Diego Basin (9)*(Basin Plan). The proposed amendment is the result of an investigation of Issue No.1 on the *Prioritized list of Basin Plan issues for investigation from September 2004 to September 2007* (Resolution No. R9-2004-0156, the 2004 Triennial Review).

This amendment edits and reformats text, and updates graphics in the Basin Plan, and includes no regulatory changes. This amendment does not constitute a California Environmental Quality Act (CEQA) project because the amendment consists of non-substantive editorial changes only. There are no changes to standards or implementation plans. The Basin Plan amendment process is authorized under Water Code section 13240.

# REINSTATED TEXT ON "CONTROLLABLE WATER QUALITY FACTORS"

This revision adds a section entitled, "Controllable Water Quality Factors" to Chapter 3, 'Water Quality Objectives' to restore text from the Basin Plan that was inadvertently omitted in the 1994 update. The revision is nonregulatory, and is authorized under Title 1 of the California Code of Regulations, section 100 (Office of Administrative Law regulations governing administrative rulemaking). This revision is not part of the proposed Basin Plan amendment.

Interested persons are invited to attend the hearing to present testimony. Oral statements will be heard, but for accuracy, important testimony should be presented in writing.

Submittal of written comments is encouraged. Written comments are due no later than April 12, 2006, at the close of the public hearing.
