Everett, are we going to receive updated SEP material today? I believe that you indicated last week that we would receive something by this week. We will need time to review it and to prepare a settlement agreement and draft order and provide 30-days notice before the Februrary, 2009 Bd meeting if we are to proceed with this case as a settlement/sep. Management is losing patience with us on this matter. If we do not receive and finalize all material, essentially within the next week, we will be forced to proceed with either a hearing on the ACL or with presentation of a Stipulation without an SEP. At this late date, we are uncertain whether we can meet the deadlines even if you submit your responses to our comments today. Unfortunately, I will be occupied on other matters for much of next week and we are fast approaching the holiday period when essential players are away on vacation. We provided comments to you quite some time ago and are disappointed that we have not already received responses. Our choices on how to proceed are fading fast. It's looking more and more as though we will be forced to proceed before the Board in the same manner that we were jammed into doing last time around, with the Prosecution Team and the City presenting a stipulation for the ACL amount, and leaving you to independently present the SEP proposal.
