Dear John Robertus and Vicente Rodriquez and members of the RWQRB:

Please schedule a public hearing in Chula Vista as soon as possible to discuss eliminating the once through cooling permit of the Southbay Power Plant. This needs to be a very high priority for the Board. Since water quality issues are your reason for existence, and this plant has polluted and degraded the quality of the water in San Diego Bay for 40 years, this needs to be stopped at once.

This degradation of the water quality of our bay must stop! Our community has the right to expect that in the future the bay water will be clean enough for safe body contact and fishing. The number of marine organisms killed by this plant is totally unacceptable and cannot be adequately mitigated off-site. The heavy metals and chemicals in the water discharged by this plant must not be allowed. It is your job to clean up the bay, not to aid and abet this continued negative impact.

Please do not extend or renew this permit. The amount of staff time required to analyze all the information that must be analyzed to allow this to continue is not acceptable. The best course of action is to just to deny it. Allowing it to administratively continue must not be an option even considered by the Board. This is the time to say NO MORE.

It is not the job of the RWQRB to decide how much electrical generation is needed for this area. The SBPP has other options if it wants to continue operating. It could upgrade to use air-cooling.
