SAN DIEGO TRUCK BODY AND EQUIPMENT INC. FOR VIOLATIONS OF STATE
BOARD ORDER NO. 97-03-DWQ, NPDES NO. CAS000001**

The Prosecution Team in the above-referenced matter has discovered a typographical error in Complaint No. R9-2010-0129 against San Diego Truck Body and Equipment, Inc. The Complaint and associated technical analysis incorrectly identified the delinquent annual fee as pertaining to the Fiscal Year (FY) 2007-2008 when it should have referred to FY 2008-2009. The technical analysis and consideration of civil liability were not affected because each was correctly based on alleged failure to pay the FY 2008-2009 annual fee.

The proposed order presented to the San Diego Water Board for its consideration on December 14, 2010 will correct the mistake.
