## **TENTATIVE RESOLUTION NO. R9-2012-0057**

## ADOPTION OF A MITIGATED NEGATIVE DECLARATION REGARDING POTENTIAL ENVIRONMENTAL IMPACTS FOR THE LEUTHE RESIDENCE ONSITE WASTEWATER TREATMENT SYSTEM ESCONDIDO, SAN DIEGO COUNTY

WHEREAS, the California Regional Water Quality Control Board, San Diego Region (hereinafter San Diego Water Board), finds that:

- 1. The project consists of adoption of Order No. R9-2012-0056, Waste Discharge Requirements for an Onsite Wastewater Treatment System/Advanced Treatment Unit (OWTS/ATU) that will serve a proposed 4-bedroom residence located at Camino Elena Road, Escondido, San Diego County (the Leuthe Residence) (APN 186-612-31).
- 2. The San Diego Water Board is functioning as the lead agency, which has the principal responsibility for approving the proposed project and is responsible for preparation of environmental documents.
- 3. The San Diego Water Board prepared an Initial Study/Environmental Checklist for the project in accordance with the California Environmental Quality Act (CEQA; Public Resources Code, section 21000 et seq.) and the State CEQA guidelines (Title 14, California Code of Regulations, section 15000, et seq.).
- 4. The environmental impacts of this project will be less than significant.
- The San Diego Water Board has prepared a Draft Mitigated Negative Declaration pertaining to the proposed discharge of waste and installation of the proposed OWTS/ATU.
- 6. A notice of intent to adopt the Draft Mitigated Negative Declaration was published in the San Diego Union Tribune on October 6, 2012 in compliance with section 15072, Title 14, California Code of Regulations.
- 7. The proposed Draft Mitigated Negative Declaration was sent to the State Clearinghouse and local responsible agencies for review.
- 8. The San Diego Water Board did not receive any comments on the proposed Draft Mitigated Negative Declaration.
- 9. The San Diego Water Board has heard and considered all comments pertaining to the Resolution in a public meeting.
