Subject: Consideration of Adoption of Tentative Order No. R9-2012-0056 and Tentative Resolution No. R9-2012-0057

Dear Mr. Leuthe

This serves to inform you that the California Regional Water Quality Control Board San Diego Region (San Diego Water Board) will consider adoption of Tentative Order No. R9-2012-0056 (tentative Order), Tentative Monitoring and Reporting Program No. R9-2012-0056 (tentative MRP), and Tentative Resolution No. R9-2012-0057 (tentative Resolution) at their scheduled meeting on Wednesday, December 12, 2012.

The tentative Order, if adopted, will establish waste discharge requirements for the discharge of treated domestic wastewater from a proposed Onsite Wastewater Treatment System/ Advanced Treatment Unit (OWTS/ATU) that will serve a 4-bedroom residence (Leuthe Residence) to be located on Camino Elena Road, Escondido, San Diego County. The tentative Resolution will adopt a mitigated negative declaration for the proposed action to adopt waste discharge requirements for the proposed OWTS/ATU. The mitigated negative declaration finds that the proposed action will not have a significant effect on the environment.
