The California Regional Water Quality Control Board, San Diego Region (hereinafter San Diego Water Board), having considered in a public meeting on December 12, 2012, all comments received on the issuance of liability against Ariel Suites, L.P. regarding violations alleged in Complaint No. R9-2012-0065, dated October 1, 2012 (Complaint), having provided public notice thereof and not less than thirty (30) days for public comment, and on the recommendation of administrative assessment of Mandatory Minimum Penalties (MMPs) in the amount of \$138,000 finds as follows:

- 1. Ariel Suites, L.P. is the developer of a 19-story 224 unit apartment building located at 735 West Beech Street, San Diego, California 92101. The downtown San Diego construction site is bordered by the trolley tracks on the West, West Beech Street to the North, Kettner Boulevard to the East, and the U.S. Bank building on the South.
- Extracted groundwater discharged to San Diego Bay is subject to San Diego Water Board Order No. R9-2007-0034, National Pollutant Discharge Elimination System (NPDES) Permit No. CAG919001 (Permit). The Permit prescribes effluent limitations for the discharge of extracted groundwater directly into San Diego Bay or indirectly via a storm water conveyance system.
- 3. On July 6, 2011, Ariel Suites, L.P. submitted a Notice of Intent (NOI) to discharge construction dewatering of groundwater to San Diego Bay via a City of San Diego storm water conveyance system inlet pursuant to the Permit.
- 4. On August 8, 2011, the San Diego Water Board enrolled Ariel Suites, L.P. under the Permit with a maximum permitted flow of 0.504 million gallons per day. Ariel Suites, L.P. was assigned Waste Discharge Identification (WDID) No. 9 000002314.
- 5. On October 4, 2011, at the request of Ariel Suites, L.P., the San Diego Water Board increased Ariel Suites, L.P.'s permitted flow rate to 0.720 million gallons per day.

6. On February 23, 2012, Ariel Suites, L.P. began discharging extracted groundwater into the City of San Diego's storm drain inlet.

- 7. Pursuant to the Permit's Monitoring and Reporting Program, Ariel Suites, L.P. submitted Self-Monitoring Reports to demonstrate compliance with Permit effluent limitations.
- 8. Pursuant to the Permit and based upon a maximum flow rate of 0.720 million gallons per day, the Copper Average Monthly Effluent Limitation (AMEL) is 2.9 ug/L and 0.0174 lbs./day; and the Maximum Daily Effluent Limitation (MDEL) is 5.8 ug/L and 0.0348 lbs./day.
- 9. Pursuant to the Permit and based upon a maximum flow rate of 0.720 million gallons per day, the Nickel Average Monthly Effluent Limitation (AMEL) is 6.8 ug/L and 0.0408 lbs./day; and the Maximum Daily Effluent Limitation (MDEL) is 13.6 ug/L.
- 10. Pursuant to the Permit and based upon a maximum flow rate of 0.720 million gallons per day, the Tetrachloroethylene (aka Tetrachloroethene) Average Monthly Effluent Limitation (AMEL) is 2.0 ug/L and 0.0120 lbs./day.
- 11. Pursuant to the Permit, the Total Suspended Solids (TSS) Average Monthly Effluent Limitation (AMEL) is 30 mg/L and the Instantaneous Maximum is 50 mg/L.
- 12. Water Code section 13385 requires that an MMP of \$3,000 be imposed for each "serious violation" of an effluent limitation. Water Code section 13385 (h)(2) defines a "serious violation" as "any waste discharge that violates the effluent limitations contained in the applicable waste discharge requirements for a Group II pollutant, as specified in Appendix A to Section 123.45 of Title 40 of the Code of Federal Regulations, by 20 percent or more or for a Group I pollutant, as specified in Appendix A to Section 123.45 of Title 40 of the Code of Federal Regulations, by 40 percent or more."
- 13. Water Code section 13385(i) requires that an MMP of \$3,000 be imposed for each nonserious violation of an effluent limitation contained in waste discharge requirements, not counting the first three violations, where there are four or more violations in any period of 180 days.
- 14. In addition to statutorily mandated MMPs, every violation of an NPDES permit is subject to discretionary liability under Water Code section 13385(a)(2), including violations not subject to MMPs under Water Code sections 13385 (h) or (i).
- 15. Pursuant to Appendix A to section 123.45 of the Code of Federal Regulations, TSS is listed as a Group 1 Pollutant; and Copper, Nickel, and Tetrachloroethylene are Group 2 Pollutants.

16. Between February and July 2012, Ariel Suites, L.P. reported violations of effluent limitations for Copper, Nickel, TSS, and Tetrachloroethylene as described in Table 1, Summary of Mandatory Minimum Penalty Violations.

- 17. On November 1, 2012, Ariel Suites, L.P. waived its right to a public hearing before the San Diego Water Board, and paid the recommended \$138,000 MMP to the California State Water Resources Control Board's "State Water Pollution Cleanup and Abatement Account."
- 18. Issuance of this Order is an enforcement action taken by a regulatory agency and is exempt from the provisions of the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.) pursuant to section 45321(a)(92), Chapter 3, Title 14 of the California Code of Regulations. This action is also exempt from the provisions of CEQA in accordance with section 15061(b)(3) of Chapter 3, Title 14 of the California Code of Regulations because it can be seen with certainty that there is no possibility that the activity in question may cause a significant effect on the environment.
- 19. The San Diego Water Board incurred costs totaling \$28,428 that includes investigation, preparation of enforcement documents and communication with Ariel Suites representatives and contractors regarding the enforcement action.

IT IS HEREBY ORDERED, that pursuant to Water Code section 13385(h) and (i) that civil liability is imposed on Ariel Suites, L.P. in the amount of \$138,000, and that Ariel Suites, L.P.'s waiver of its right to a public hearing and offer of \$138,000 in satisfaction of Complaint No. R9-2012-0065 is accepted.
