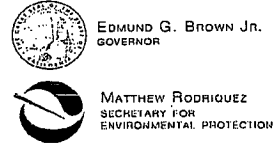

Enclosed is a copy of Tentative Addendum No. 1 to Order No. 97-49 (tentative Addendum), which, if adopted, would modify Order No. 97-49, *Waste Discharge Requirements and Water Recycling Requirements for the Production and Purveyance of Recycled Water for Padre Dam Municipal Water District, San Diego County*. The proposed tentative Addendum would modify Order No. 97-49 by adding requirements for use of recycled water for street sweeping and sewer flushing. The proposed tentative Addendum would also require Padre Dam Municipal Water District to submit a work plan for development of a salt and nutrient management plan.


