Thank you for the opportunity to comment on the San Diego Regional Water Quality Control Board's Tentative Order No. R9-2013-002 (General Waste Discharge Requirements for Discharges from Boatyards and Boat Maintenance and Repair Facilities Adjacent to Surface Waters within the San Diego Region). The City of San Diego, Transportation & Storm Water Department (City) is committed to protecting and improving water quality in our region. The City believes that implementing chronic toxicity testing on samples collected prior to the point of discharge during qualifying storm events as described in Attachment E Section IV.A.1 is not representative of the impact of storm water runoff on marine species. Freshwater discharges to marine environments will create conditions in the immediate zone of influence that cannot be tolerated by marine species, regardless of storm water cleanliness. A receiving water dilution zone should be considered for compliance purposes in marine receiving water environments influenced by freshwater runoff, as done in the California Ocean Plan Appendix I Definition of Terms. The City recommends that the sample location be moved into the receiving water mixing zone where marine species can tolerate the receiving water salinity.
