PURPOSE: To receive public testimony and consider adoption of

Tentative Order No. R9-2013-0001 (Tentative Order).

RECOMMENDATION: Adoption of the revised Tentative Order No. R9-2013-0001,

with corrected Option 1 Errata or Option 2 Errata, is

recommended.

DISCUSSION: This Executive Officer Summary Report (EOSR)

supplements the EOSR provided for Item 9 of the May 8,

2013 San Diego Water Board meeting.

Cost Benefit Analysis Report

At the April 10 and 11, 2013 meeting, the San Diego Water Board allowed a cost benefit analysis report prepared by the

City of San Diego Transportation and Storm Water

Department entitled Meeting Water Quality Standards for San Diego's Recreational Waters: A Cost Benefit Analysis dated April 2011 (Cost Benefit Analysis) (Supporting

Document 4) into the record. The City of San Diego funded this analysis to evaluate the costs of compliance for the City of San Diego with total maximum daily loads (TMDLs) for bacteria, metals, pesticides or other pollutants. The San Diego County Copermittees referenced this Cost Benefit Analysis in their April 2013 public hearing testimony before the San Diego Water Board in support of their request to remove the bacteria TMDL from the Tentative Order. The County of San Diego specifically requested the Cost Benefit Analysis be allowed into the record on the Tentative Order. The request was **not** made on behalf of all Copermittees as

was stated in the first EOSR for Item 9.

The San Diego Water Board Chair invited designated parties wishing to submit comments on the Cost Benefit Analysis, to submit them to the San Diego Water Board no later than 5:00 p.m. on Friday, April 26, 2013. Timely submitted comment letters are included in **Supporting Document 5**. Comment letters were received from San Diego and Orange County Copermittees, Natural Resources Defense Council, San Diego and Orange County Coastkeeper, Inland Empire Waterkeeper, Building Industry Coalition, Clean Water Now, San Diego Taxpayers Association, and San Diego Regional Chamber of Commerce. Where comments referred to existing studies for support, only those studies already a part of the record for Tentative Order No. R9-2013-0001 are included in **Supporting Document 5**.

Cost Information

Regional Storm Water Program Expenditures FY 2011/2012 (Supporting Document 6) and the Comprehensive Load Reduction Plan Estimated Cost (Supporting Document 7) are included to assist the San Diego Water Board's discussion on costs. This information is already in the record and the cost spreadsheets were previously provided to the San Diego Water Board at the December 2012 workshop. The information used to generate the spreadsheets provided in Supporting Documents 6 and 7 was excerpted from the Copermittees 2012 Storm Water Program Jurisdictional Annual Reports (Supporting Document 8).

Congressional and California Legislature Comments

Additionally, at its April 10 and 11, 2013 meeting, the San Diego Water Board Chair, accepted into the record, a letter addressed to USEPA from several Members of the United States Congress dated April 2, 2013. (Supporting Document 9) The San Diego Water Board also accepted into the record a letter addressed to the Board Chair from several California State Legislature Senators and Assembly Members dated April 4, 2013 (Supporting Document 10). The Congress Members comments included a request that USEPA review the Tentative Order for potential impact on local communities to ensure that costs of compliance and schedules are sustainable and reasonable. The comments from the California State Legislature Senators and Assembly Members included a request to delay adoption of the Tentative Order to allow for the State Water Board review of existing precedential receiving water language and further

Board and stakeholder review of estimated costs of compliance with the bacteria TMDL. The USEPA response to the United States Congress Members letter is included as **Supporting Document 11**.
