

**CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD SAN DIEGO

TENTATIVE ORDER NO. R9-2016-0015

AN ORDER RESCINDING ORDERS NOS. 93-09 AND 94-161

The California Regional Water Quality Control Board, San Diego Region, (hereinafter San Diego Water Board), finds that:

1. On February 1, 1993, the San Diego Water Board adopted Order No. 93-09, *Waste Discharge Requirements for the Heise Park Campground Plant, County of San Diego Parks and Recreation Department*. Order No. 93-09 established requirements for the discharge of domestic wastewater from the William Heise Park Water Pollution Control Facility located south of Julian in San Diego County.
2. On December 8, 1994, the San Diego Water Board adopted Order No. 94-161, *Waste Discharge Requirements for the County of San Diego, Pine Valley Sanitation District, Pine Valley Water Pollution Control Facility, San Diego County*. Order No. 94-161 established requirements for the discharge of domestic wastewater from the Pine Valley Water Pollution Control Facility (WPCF) located approximately 45 miles east of San Diego in San Diego County.
3. The County of San Diego submitted a Report of Waste Discharge (ROWD) for both the Heise Park Campground Plant and the Pine Valley WPCF dated January 2015 and May 2015 respectively, requesting modifications to Orders Nos. 93-09 and 94-161.
4. Based on the information in the ROWDs both discharges are eligible to enroll in Order No. WQ 2014-0153-DWQ *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems (General Order)*.¹
5. On January 12, 2016 San Diego Water Board staff inspected the facilities and verified that the facilities were eligible for enrollment in the General Order.
6. The San Diego Water Board issued a Notice of Applicability for enrollment in the General Order to the County of San Diego for each facility on February 10, 2016. The NOAs set the effective date of enrollment in the General Order to coincide with the date of adoption of this rescission Order.
7. The San Diego Water Board in a public meeting heard and considered all comments pertaining to the rescission of Orders Nos. 93-09 and 94-161.

8. This Order rescinds waste discharge requirements (WDRs) for two water pollution control facilities that will be enrolled in the General Order for ongoing operation. It can be seen with certainty that there is no possibility that rescinding the WDRs will have an adverse impact on the environment. This Order is therefore exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with the California Code of Regulations (Cal. Code Regs.) title 14, section 15061(b)(3). Adoption of this Order does not enroll the facilities in the General Order, however because the facilities are existing and not adding or changing their treatment processes, enrollment of the facilities in the General Order through issuance of Notices of Applicability does not require additional CEQA compliance beyond that completed by the State Water Resources Control Board when it adopted the General Order. (See General Order, Finding 32.a.)

IT IS HEREBY ORDERED that Orders Nos. 93-09, and 94-161 are rescinded.
