**NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing, for public review and comment:

- Tentative Order No. R9-2016-0015 rescinding Orders Nos.93-09 and 94-161

The Tentative Order rescinds waste discharge requirements for the Heise Park Campground Plant and the Pine Valley Water Pollution Control Facility. Both facilities are owned and operated by the County of San Diego.

**Submission of Written Comments**

Notice is hereby given that the San Diego Water Board will receive written comments on the aforementioned Tentative Order in accordance with this notice pursuant to Water Code section 13167.5.

The submission of written comments is the opportunity for interested persons to raise and comment on issues pertaining to the Tentative Order. All written comments pertaining to the Tentative Order to be considered by the San Diego Water Board must be received **no later than 5:00 p.m. on February 19, 2016**. Comments should be submitted electronically to [sandiego@waterboards.ca.gov](mailto:sandiego@waterboards.ca.gov) in text searchable Portable Document Format (PDF) or Microsoft Word format. Written comments can also be submitted via regular mail to the San Diego Water Board office at 2375 Northside Drive, San Diego, CA 92108. Please indicate in the subject line of the email or comment letter "Comment – Tentative Order No. R9-2016-0015, Attn Alex Cali." The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on February 19, 2016**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received.

Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after 5:00 p.m. on February 19, 2016, will not be accepted, and will not be incorporated into the administrative record if doing so would prejudice any party.

### **Public Hearing for Consideration of Tentative Order Adoption**

A public hearing on the Tentative Order will be held during the San Diego Water Board meeting scheduled for Wednesday, March 9, 2016, in the Board Meeting Room, 2375 Northside Drive, San Diego, California, 92108. This item will be heard during a meeting that starts at 9:00 a.m. The meeting agenda, which will indicate any changes in the meeting location and may provide other specific information concerning this hearing, will be posted at least two weeks prior to the meeting date at [http://www.waterboards.ca.gov/sandiego/board\\_info/agendas/](http://www.waterboards.ca.gov/sandiego/board_info/agendas/)
