This letter serves to inform you that the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) will consider adoption of Tentative Order No. R9-2017-0102 (Tentative Order) at its scheduled meeting on Wednesday, October 11, 2017. 

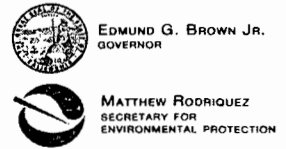


