Tentative Order No. R9-2018-0069 for the Sycamore Landfill

Mr. Mohr:

This letter is to inform you that the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) has revised Tentative Order No. R9-2018-0069 Waste Discharge Requirements for Sycamore Landfill, San Diego County (Revised Tentative Order) and the associated monitoring and reporting program.

The San Diego Water Board will consider adoption of the Revised Tentative Order at its scheduled meeting on Wednesday, December 12, 2018. The Revised Tentative Order prescribes waste discharge requirements for monitoring, solid waste disposal operations including the acceptance of special wastes (i.e., non-municipal solid waste (MSW) waste streams), maintenance, reporting, design and construction criteria for all future expansion units at the Sycamore Landfill. Revisions made to the Tentative Order, Monitoring and Reporting Program, and Information Sheet since the original release of the permit package for public review on August 29, 2018 are shown in redline strikeout format.
