NOTICE OF PUBLIC WORKSHOP

ADMINISTRATIVE DRAFT OF A
PROPOSED BASIN PLAN AMENDMENT
TO THE WATER QUALITY CONTROL PLAN FOR THE SAN DIEGO BASIN TO
ESTABLISH BIOLOGICAL WATER QUALITY OBJECTIVES

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) will hold a public workshop to provide an opportunity for discussion and to receive comments and information from the public on an Administrative Draft of a proposed amendment to the Water Quality Control Plan for the San Diego Basin (Basin Plan) to establish biological water quality objectives (biological objectives) for surface waters in the San Diego Region. The public workshop will be conducted during a regularly scheduled meeting of the San Diego Water Board. No action or voting on this item will occur, but San Diego Water Board members may provide direction to staff.

Public Workshop

The objective of the workshop is to inform the public about the Administrative Draft of the proposed Basin Plan amendment and to receive information regarding community perspectives on the Administrative Draft. The public is invited to present comments and ask clarifying questions. Written comments may also be submitted in advance to help frame the discussion during the workshop. Comments and information received during the workshop will be considered by the San Diego Water Board in finalizing a tentative Basin Plan amendment that will be released for formal public review and comment at a later date.

The San Diego Water Board will consider any comments received on the Administrative Draft. Comments received by February 23, 2018, will be included in the administrative record for the Tentative Basin Plan amendment but will not receive written responses. The San Diego Water Board will issue a separate public hearing notice announcing the release of the Tentative Basin Plan amendment and substitute environmental documentation for formal public review and comment in accordance with 23 CCR §. 3779 and 40 C.F.R. § 25.5(b) and 25.10.

Background

The objective of the Clean Water Act is to restore and maintain the chemical, physical, and biological integrity of the Nation's waters. The Water Quality Control Plan for the San Diego Basin designates beneficial uses for water bodies in the San Diego Region and establishes water quality objectives and implementation plans to protect those beneficial uses. Existing water quality objectives in the San Diego Water Board's Basin Plan emphasize the chemical integrity of waters on a pollutant-by-pollutant basis, which might not adequately protect the biological integrity of waters.

The San Diego Water Board 2014 triennial review of water quality standards identified the amendment of the Basin Plan to incorporate biological water quality objectives as a high priority in order to protect and restore beneficial uses associated with aquatic and aquatic dependent wildlife. On May 13, 2015, the San Diego Water Board adopted Resolution R9-2015-0043, which directed staff to begin working on the project to amend the Basin Plan to incorporate biological water quality objectives. The goal and intent of the biological objectives project is to establish a water quality objective based on the biological integrity of the organisms (e.g. macroinvertebrates) in the water body. Adopting biological water quality objectives would allow the San Diego Water Board to use biological assessment ("bioassessment") to better assess, protect, and restore surface waters and related beneficial uses.

The San Diego Water Board will be proposing to amend the Basin Plan to incorporate a general narrative biological water quality objective for all water bodies in the San Diego Region and a numeric biological water quality objective for wadable streams. The proposed narrative biological objective would apply to surface waters in the San Diego region, and is drafted as follows:

Surface waters within the San Diego Region shall support an ecologically balanced and resilient community of organisms having a native species composition, diversity, abundance, and functional organization commensurate with that of unaltered analogous waters.

The proposed numeric biological water quality objective would use the California Stream Condition Index, in combination with additional lines of evidence for chemistry and stream habitat, to score the condition of a wadeable stream in comparison to reference streams. Both the narrative and numeric biological water quality objectives would be implemented through the San Diego Water Board's existing permitting and planning programs.
