PURPOSE: The purpose of the item is to inform the public and the Board

on a trash reduction campaign by Sierra Club Angeles Chapter and OC Coastkeeper. Hoiyin Ip of the Sierra Club

will be presenting to the Board.

RECOMMENDATION: This is an informational item and the Board will not take an

action.

KEY ISSUES: In this throw-away culture, people's reliance on single-use

products has caused many environmental issues, including the plastic ocean. State Water Board's adoption of trash provisions is a much needed step for government agencies

to address the issue,

PRACTICAL VISION: The trash provisions compliance should include both trash

capture and prevention.

DISCUSSION: The municipalities are well into their first year of the

implementation of trash provisions compliance. While it's important to install and maintain full capture systems to prevent trash entering the waterways, it's even more important and cost effective to address trash reduction and

prevention at the source.

As a start, Sierra Club Angeles Chapter and OC

Coastkeeper have proposed in Region 8 that the County and Cities initiate a campaign to encourage reduced reliance on single-use products used at restaurants, coffee shops, bars and hotels, the type of trash that is commonly seen in

streets, at beaches, and in waterways.

- beverage bottles
- plates, bowls, cups
- · cutlery, lids, stirrers, straws
- to-go containers and bags
- · condiment packets
- napkins

An Education Campaign would promote (through social media, public events, public service announcements, city banners, countywide signage and trash bill inserts) the message to "Serve on Request" and "Bring your Own". Californians have proved our adaptability and made impressive behavioral changes with regard to single-use plastic bags and water consumption to name just a few recent successes! The Regional Board is perfectly positioned to continue to lead by example to promote joint efforts by city and county agencies! Perhaps the Regional Board can start by linking its Trash Reduction web content to Cal EPA's.
