**NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing *Tentative Addendum No. 1 to Order No. R9-2012-0054, Waste Discharge Requirements for the San Diego County Sanitation District, Harmony Grove Water Reclamation Plant, San Diego County* (Tentative Addendum) for public review and comment. The San Diego Water Board will consider adoption of the Tentative Addendum at its regularly scheduled meeting on **June 12, 2019**. The Tentative Addendum, if adopted, will amend Order No. R9-2012-0054, *Waste Discharge Requirements for The San Diego County Sanitation District, Harmony Grove Water Reclamation Plant* to reflect transfer of ownership to the Rincon del Diablo Municipal Water District.

**Submission of Written Comments**

Notice is hereby given that the San Diego Water Board will receive written comments on the Tentative Addendum in accordance with this notice pursuant to California Water Code section 13167.5. The written comment period provides an opportunity for interested persons to comment on the Tentative Addendum. All written comments regarding the Tentative Addendum must be received no later than **5:00 p.m. on Thursday, May 16, 2019**, to be considered by the San Diego Water Board. Written comments sent by mail must be addressed to California Regional Water Quality Control Board – San Diego Region, 2375 Northside Drive, Suite 100, San Diego, California 92108-2700, and ATTN: Mr. Brandon Bushnell. Comments can also be submitted by e-mail to [sandiego@waterboards.ca.gov](mailto:sandiego@waterboards.ca.gov). The subject line of all written comments must include “Comment – Tentative Addendum No. 1 to Order No. R9-2012-0054.”

The early submission of written comments regarding the Tentative Addendum is encouraged. Written comments received by **5:00 p.m. on Thursday, May 16, 2019**, will be provided to the San Diego Water Board members for review in advance of the public hearing to consider adoption of the Tentative Addendum. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this

proceeding, written comments received after **5:00 p.m. on Thursday, May 16, 2019**, will not be accepted, and will not be incorporated into the administrative record if doing so would prejudice any party.

**Public Hearing for Consideration of the Tentative Addendum**

A public hearing on the Tentative Addendum will be held during the San Diego Water Board meeting on **Wednesday, June 12, 2019**. The meeting will begin promptly at **9:00 a.m.** and will be held in **San Diego Water Board Meeting Room, 2375 Northside Drive, Suite 100, San Diego, California 92108**.

The *Meeting Notice and Agenda*, which will indicate any changes to the meeting location and may provide other specific information regarding this hearing, will be posted at least two weeks prior to the meeting date at the following webpage:
