Hi Brandon,

On Friday, December 7th I met with Mark Peabody and Ken Johansson at the Commercial Vehicle Enforcement Facility in Tecate to inspect the disconnection of the facility's vehicle bay collection system from the existing septic system. The attachment is a photo showing that the two systems are permanently disconnected. The septic system is now receiving only domestic wastewater from the facility's restroom and is in compliance with the County of San Diego's Local Agency Management Program. If the existing septic system should fail, Caltrans would work with the Department of Environmental Health (DEH) to obtain a permit for the installation of a replacement septic system. Additionally, DEH is of the understanding that the Regional Water Quality Control Board will maintain oversight of the vehicle bay collection system which will continue to receive and accumulate small discharges of wastewater until pumping is eventually necessary. Please let me know if any additional information is needed.

Hey Craig,

As discussed over the phone I am sending you some more information on Tecate Truck Inspection facility owned and operated by Caltrans. Attached you will find a recent monitoring report submitted to the San Diego Water Board as required by their current permit. I am also attaching the current permit that contains the basic information about the site. It is averaging less than 50 gallons a day and like I said on the phone we do not see any need for them to continue sampling and monitoring. Caltrans prepared a letter for you explaining the system in more detail and expressing why they would like to be enrolled in the LAMP so that should be coming your way shortly. If you have any further questions or concerns about regulation you can call or email me or if you have questions about the facility itself, you can reach out to Mark Peabody at Kleinfelder who is Caltrans consultant for this site, 323-896-2720.
