SUBJECT

Basin Plan Amendment: Consideration of a Proposed Resolution Adopting an Amendment to the Water Quality Control Plan for the San Diego Basin to Incorporate a Water Quality Objective for Biological Condition, Including Staff Report with Substitute Environmental Documentation (Tentative Resolution No. R9-2020-0234). (Chad Loflen)

STAFF RECOMMENDATION

Staff recommends adoption of Tentative Resolution R9-2020-0234.

KEY ISSUES

The public hearing portion of this item was closed on November 18, 2020. The Board will deliberate and vote on this item during this meeting. If revisions are proposed to the November 18, 2020 hearing materials, the Board may allow limited oral comment related only to the revisions.

Key issues raised during the November 18, 2020 public hearing include:

- 1. Whether the proposed numerical objective could reasonably be achieved over time in all applicable soft-bottom modified channels.
- 2. Whether municipal agencies would be responsible for physical habitat restoration in channelized streams even if they comply with their discharge permit requirements.

PRACTICAL VISION

The Practical Vision rests on the ability to realize environmental outcomes from our actions. Biological water quality objectives are necessary to adequately evaluate, protect, and restore beneficial uses of water for aquatic ecosystems. The proposed numerical biological water quality objective for perennial and seasonal streams uses the best available science to produce accurate measurement of stream biological integrity for the region and provides a clear numerical threshold for the protection and restoration of beneficial uses. Implementation by the regulated community to achieve the proposed objective can be achieved with reasonable planning and management practices similar to those used for existing waste discharge requirements to achieve other water quality objectives. And having an objective that reflects actual biological integrity promotes the transparency and stewardship values of the Practical Vision.
