The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2020-0187, *An Order Rescinding Order No. 94-131, Waste Discharge Requirements for Shiloah Springs Bible Retreat, Inc., Indian Hills Camp, San Diego County* (Tentative Order), for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **October 14, 2020**. The San Diego Water Board will prepare written responses to significant comments that are timely received.

Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Tuesday, September 15, 2020**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
