The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **February 9, 2022**. The Tentative Order, if adopted, will rescind Order No. 88-24, Waste Discharge Requirements for Indian Oaks Trailer Ranch, Riverside County.

Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Monday, November 29, 2021**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
