**NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), is releasing Tentative Order No. R9-2023-0130, *Rescission of Order Nos. 88-15, 88-75, and 95-86 Waste Discharge Requirements for the Shamrock Sand and Rock Corporation Aguanga Sand Plant, Escondido Ready-Mix Concrete, Inc., and the Superior Ready Mix Concrete, L.P. Fallbrook Plant* (Tentative Order), for public review and comment. The San Diego Water Board will consider adoption the Tentative Order at its regularly scheduled meeting on **October 11, 2023**. The Tentative Order, if adopted, will rescind:

1. Order No. 88-15, *Waste Discharge Requirements for Shamrock Sand and Rock Corporation, Aguanga Sand Plant, Riverside County,*
2. Order No. 88-75, *Waste Discharge Requirements for Escondido Ready-Mix Concrete, Inc. in the City of Escondido, and*
3. Order No. 95-86, *Waste Discharge Requirements for Superior Ready Mix Concrete, L.P. Fallbrook Plant, San Diego County.*

**Submission of Written Comments**

Notice is hereby given that the San Diego Water Board will accept written comments regarding the Tentative Order in accordance with this notice.

The written comment period provides an opportunity for interested persons to comment on the Tentative Order. All written comments regarding the Tentative Order must be received no later than **5:00 p.m. on Friday, September 1, 2023**, to be considered by the San Diego Water Board. The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Friday, September 1, 2023**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider the adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Friday, September 1, 2023**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
