I'm writing to express my support for your tentative Cease-and-Desist order regulating an additional 10 million gallons per day at the IBWC International Treatment Plant on the Tijuana River. San Diego Regional Water Quality Control Board Members,

I am writing to strongly urge this Board's continued leadership in actively influencing, supporting, and prioritizing immediate solutions to solve the public health crisis caused by decades of sewage pollution in the Tijuana River Valley. I write in support of the proposed cease-and desist order authorizing the advance primary treatment of an additional 10 million gallons per day at the IBWC International Treatment Plant, increasing capacity from 25 million gallons to 35 million gallons per day. This action is urgently needed to reduce the flow of untreated sewage through the Tijuana River Valley, protect the health of San Diego County residents, and bring long-overdue relief to South Bay families who have endured exposure to toxic pollution for generations.

The San Diego Water Board's Practical Vision is guided by its mission to "preserve, enhance, and restore the quality of California's water resources for the protection of the **environment, public health**, and all beneficial uses." This mission is more than aspirational. It demands immediate action where public health and environmental protection intersect. The crisis in the Tijuana River Valley is exactly the type of generational challenge that this board is appointed to address, requiring urgent intervention to

safeguard our waters, restore community trust, and deliver the dignity of clean air and water to residents who have borne disproportionate impacts for decades.

Recent studies by the Centers for Disease Control and Prevention confirm what our constituents in my district have been reporting for years: dangerously high rates of illness tied directly to sewage exposure. Over 70% of residents surveyed in South County reported falling ill, a staggering statistic that underscores the severity of this ongoing emergency. Families, Navy personnel, and Border Patrol officers are all at risk from the toxic gases released when untreated sewage overwhelms our infrastructure. These reports are the daily realities for our communities, and they demand immediate intervention from elected and appointed officials who are tasked with the protection of public health and the environment.

Beyond expanding treatment capacity, immediate action must also begin at the Saturn Boulevard hotspot. I urge the Water Board to immediately work with the County of San Diego to expedite a major maintenance project at this location that will restore natural flow and reduce turbulence, which is a major factor contributing to the emission of hydrogen sulfide and other toxic gases that threaten our community's health and safety. Removing this obstruction is not only critical for water quality but also for reducing airborne hazards that endanger our children, seniors, and frontline workers. I encourage this Board to support the County in navigating and streamlining any regulatory requirements so that critical protections for community health can be delivered as quickly as possible.

Approving these measures will help reopen our beaches and businesses, protect our military readiness, and finally provide our communities with the dignity of clean air and water. For too long, our residents have borne the burden of this cross-border pollution. It is time to provide the comprehensive, structural fixes needed to protect public health and finally resolve this crisis.

Thank you for your leadership and attention to this urgent matter. I look forward to working with you to advance these solutions and ensure our residents are no longer treated as collateral damage in this decades-long environmental disaster.

Dear Chair Strawn and Board Members,

Please accept these comments on behalf of Coastal Environmental Rights Foundation ("CERF") and San Diego Coastkeeper ("Coastkeeper"). Our organizations have been involved in the cross-border public health and environmental crisis at the border for years. The ongoing sewage discharges into the Tijuana River and Pacific Ocean demand immediate attention and long-term solutions. For these reasons, Coastkeeper and CERF appreciate and support USIBWC and the Regional Board's swift action to enable the interim expanded treatment capacity of the South Bay International Wastewater Treatment Plant ("SBIWTP"). The Cease and Desist Order No. R9-2025-0139 ("Order") will enable expanded plant capacity and establish interim measures to expedite construction and treatment.

Billions of gallons of contaminated water containing dangerous pathogens and industrial pollutants have flowed into U.S. waters, forcing near-continuous beach closures from the border through Imperial Beach and harming air and water quality for local communities on both sides of the border.

Removing 10 MGD of raw sewage from the Tijuana River, treating it to "Advanced Primary," and discharging it three miles offshore will greatly reduce public health impacts for local communities and reduce or eliminate dry weather flows of raw sewage in the river. Years of continuous sewage flows have devastated the River and Estuary, with serious air quality and health impacts for those living and working in the region. According to USIBWC's August 13, 2025 update, dry-weather flows have already dropped from 10–12 MGD earlier this summer to about 5 MGD, down from historical highs of 40 MGD. This expansion has the potential to completely eliminate dry-weather flows for the first time in years.

The U.S. EPA and USIBWC's commitment to the expansion within 100 days marks the fastest significant U.S. border-side infrastructure project in more than three decades to address transboundary pollution. CERF and Coastkeeper support those efforts and the critical role this Order will play to enable the project to proceed pending completion of further analysis and permit amendments.

CERF and Coastkeeper echo the Regional Board, UWIBWC, and U.S. EPA's calls for continued ongoing infrastructure improvements, coupled with the operation, maintenance, and funding to support them. While this project is a major step forward, its success depends on sustained efforts to properly operate and maintain the equipment. We support USIBWC and EPA's commitment to secure the necessary funding to ensure the expansion's success. Coastkeeper and CERF will continue to monitor the progress on the 100 day treatment expansion and other planned infrastructure improvements on behalf of the communities and coastal environment we serve.

We are the citizens who are most directly affected by the sewage crossing our border and being dumped into our river and ocean river environment. *Our South Bay Community is opposed to the increase of 10 million gallons per day (mgd) of additional partially treated sewage being discharged to the South Bay Ocean Outfall (SBOO) as requested by the International Boundary and Water Commission. The basis of this opposition is large errors of understanding in the Background Information which the water board based its decision on the Cease-and-Desist order number R920250139. There are critical inaccurate understandings of the source of contamination which misrepresent and sequester the boards full understating of the impacts to our community. The Background Information does not accurately reflect all the known historical scientific data, current water testing data that show the direct threat to the public health if 10 million gallons of additional partially treated effluent will bring to our communities.*

We ask the Water Quality Board to consider, understand and have compassion that at current levels of discharge of 40 million gallons per day our citizens are experiencing the direct negative health effects of bad air quality, river and ocean water contamination, which the long-term health effects have yet to be fully realized.
