Item 1 – Public Hearing: Consideration of Tentative Cease and Desist Order to United States Section of the International Boundary and Water Commission (USIBWC), South Bay International Wastewater Treatment Plant, Discharge to the Pacific Ocean through the South Bay Ocean Outfall (Tentative Cease and Desist Order No. R9-2025-0139).
