#### MINUTES OF MEETING March 9, 2005

# Item 2 – Public Forum

Laura Hunter, Environmental Health Coalition, talked about a report they released titled "Survey of Fishers on Piers in San Diego Bay."

Sonia Rodriguez, Environmental Health Coalition, said she was the one that conducted the survey on the piers and urged cleanup of the bay.

Alfredo Lopez, fisherman at National City pier, said he was concerned for his family who eat the fish he catches and urged the Board to take action to get the bay cleaned up.

Jack Eidt, Wild Heritage Planners, said they wanted to designate the San Mateo watershed under the Critical Coastal Area Program.

Jerry Collamer, Surfrider Foundation, also talked about the Critical Coastal Area Program and protecting the creeks.

Michael Pallamary, land use consultant, informed the Board of several alleged violations associated with the construction of the Carmel Valley Trunk Sewer project and asked the Board to look into the matter.

John Millar, Rancho Del Sol Nurseries, also talked about the above alleged violations.

Michael Hazzard, Clean Aliso Creek Association, requested an agenda item in Laguna Beach on May 11, 2005 to talk about Aliso Creek issues.

Gabriel Solmer, San Diego BayKeeper, talked about the Border fence between San Diego and Tijuana issue they talked about last month and urged the Board to contact key senators to get the hearing process in place in order for the environmental impacts to be considered.

## Item 3 – Minutes of Board Meeting of February 9, 2005

Mr. Robertus noted that a correction needed to be made to page 2, under Public Forum, speaker David Merk, the word "haul" should read "hull" in two places.

Mr. Wright moved approval of the February 9, 2005 minutes with the correction. The motion was seconded by Ms. Ritschel and approved by unanimous vote.

Mr. Wright moved approval of Order No. R9-2005-0015. The motion was seconded by Ms. Kraus and approved by unanimous vote.

Both oral and written comments will be received by the Regional Board regarding these items up to and during today's hearing. The Regional Board will schedule a subsequent date for deliberating on all testimony and making a decision on the adoption of tentative Order Nos. R9-2005-0005 and R9-20005-0006.

Ms. Kraus disclosed that she was an Industrial Environmental Association Board member, which Southern California Edison was a member of but felt it would not influence her actions on the item.

Mr. Robertus introduced the item and staff member Hashim Navrozali gave the presentation.

Board Members asked questions of staff and Mr. Richards.

Other speakers included: David Kay, Southern California Edison Bill Paznokas, Department of Fish and Game Jerry Collamer, Surfrider Foundation and Sierra Club Jack Eidt, Wild Heritage Planners Bruce Reznik, San Diego BayKeeper Laura Hunter, Environmental Health Coalition Al Huang, Environmental Health Coalition Ed Kimura, Sierra Club Gabriel Solmer, San Diego BayKeeper Patti Krebs, Industrial Environmental Association Michael Hazzard, Citizen Watershed Monitors

Mr. Kay made closing comments.

Robert Heckler, SONGS, answered a question about monitoring asked by Ms. Ritschel.

Board Members asked questions of staff.

Senior staff member John Phillips made closing comments.

Mr. Wright said that he would like to keep the public comment period open so that interested parties could comment on staff's response to comments.

Mr. Robertus recommended closing the public comment period at 5:00 p.m.

Ms. Ritschel made a motion to leave the public comment period for an additional two weeks. Mr. Anderson seconded the motion.

Board Members made comments and made requests of staff.

The motion was approved with opposition by Mr. Wright.

**Item 6** – PUBLIC HEARING: A public hearing may be held regarding the issuance of Cleanup and Abatement Order No. No.R9-2005–0033 to Fieldstone Communities Inc. for alleged violations of the California Water Code caused by discharges of excessive amounts of sediment from the Oak Hill residential development site in the City of Oceanside. (*Christopher Means*)

<u>Item 7</u> – PUBLIC HEARING: A public hearing may be held regarding the issuance of Cleanup and Abatement Order No.R9-2005–0044 to Florida SouthChase LP for alleged violations of the California Water Code caused by discharges of excessive amounts of sediment from the Morro Hills Villages residential development site in the City of Oceanside. (*Christopher Means*)

Mr. Robertus introduced the items and Mr. Richards framed the issues. Staff member Christopher Means gave the presentation.

Other speakers included: Wayne Rosenbaum, Foley and Lardner, represented the dischargers.

Mr. Rosenbaum stopped his presentation to allow Board discussion of his two issues before proceeding further.

Chairman Minan reviewed the two requests and discussed them with Mr. Rosenbaum and Mr. Richards.

The meeting was recessed for lunch 1:10 p.m. and reconvened at 1:45 p.m.

# Item 6 - Continued

Mr. Rosenbaum continued with his presentation.

Mr. Means made brief closing comments. Mr. Robertus recommended that the Board affirm the Cleanup and Abatement Orders.

Chairman Minan recommended amending the orders by adding the following language, taken from the Policy and Procedures Manual, to the end of the order,

after the signature line: "The Regional Water Quality Control Board reserves its right to take any enforcement action authorized by law."

Ms. Ritschel recommended amending the orders by adding the following language: "Rescission of the CAO will be considered when the Executive Officer has determined that Fieldstone Communities (*Florida SouthChase*) had complied with the directive in the CAO."

Ms. Ritschel motioned to affirm Order No. R9-2005-0033 with Addendum No. 1 and the two amendments. The motion was seconded by Ms. Kraus and approved by unanimous vote.

Ms. Ritschel motioned to affirm Order No. R9-2005-0044 with Addendum No. 1 and the two amendments. The motion was seconded by Ms. Kraus and approved by unanimous vote.

<u>Item 8</u> – PUBLIC HEARING: Addendum to Cleanup & Abatement Order: Mission Valley Terminal (tentative Addendum No. 5 or Order No. 92-01) (*Kelly Dorsey*)

Mr. Robertus introduced the item and staff member Kelly Dorsey gave the presentation.

Other speakers included: Richard Opper, Opper & Varco, represented the City of San Diego Marci Steirer, City of San Diego Chris Gonaver, City of San Diego Curt Stanley, Shell Global Solutions Kevin Ryan, Kinder Morgan

Mr. Opper made brief closing comments.

Ms. Dorsey addressed Mr. Opper's and Mr. Stanley's concerns and made closing comments.

Ms. Dorsey recommended revising directive no. 2 to include language requiring cleanup to background water quality and no. 4 to include language to clarify the requirements of the feasibility study, add clarifying language and correct various typographical errors.

Ms. Dorsey recommended closing the public comment period.

Per Mr. Opper's request, Mr. Robertus asked staff to include in the findings a reference to the agreement that was reached between the City and Kinder Morgan regarding future remedial work for the site.

Senior staff member John Odermatt addressed a question concerning Shell Oil asked by Mr. Wright.

Chairman Minan recommended adding the following language, taken from the Policy and Procedures Manual, to the end of the order, after the signature line: "The Regional Water Quality Control Board reserves its right to take any enforcement action authorized by law."

Chairman Minan recommended adding the statement: "as soon as practicable or.." to page 2 of the tentative order, before the dates that cleanup is to be completed.

Ms. Ritschel motioned to close the public hearing and public comment period. The motion was seconded by Mr. Wright and approved by unanimous vote.

Board Member Ritschel left the meeting at 3:30 p.m.

<u>Item 9</u> – Status Report: U.S. Navy–Status of Alternative Toxicity Study (*John Phillips*)

Mr. Robertus introduced the item and staff member Paul Richter gave the presentation.

Other presenters included: Rob Chichester, U.S. Navy Chuck Katz, U.S. Navy

Board Members asked questions of Mr. Chichester and Mr. Katz.

Chairman Minan made a recommendation to the Navy.

<u>Item 10</u> – Report on Settlement of Litigation: *People of the State of California Ex Rel. the Regional Water Quality Control Board, San Diego Region v. City of San Diego*, U.S. District Court, Southern District of California, Case No. 03CV1381-B(POR) (John Robertus) Chairman Minan suggested making changes to the language in the Terms of Proposed Settlement, items B and C, which would read:

B. \$260,000 to the **Southern California Coastal Water Research Project Authority** for the purpose of conducting a sediment toxicity source analysis water quality project in Chollas Creek **as directed by the Regional Board**;

C. \$500,000 to **an interest bearing escrow account to fund** water quality related monitoring in San Diego Bay and Mission Bay **as directed by the Regional Board**;

Mr. Robertus said he would publish the corrections in the notifications section of the April 13, 2005 agenda.

Ms. Kraus made a motion to authorize Mr. Robertus to sign the settlement agreement with the changes noted by Chairman Minan. The motion was seconded by Mr. Barrett and approved by unanimous vote.

<u>Item 11</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Mr. Richards gave the Board an update on the William Johnson court case.

Mr. Robertus briefly talked about the 2005 Community Leaders Water Forum, and commented on the Update of the Bacteria-Impaired Waters Total Maximum Daily Load Project I for Beaches and Creeks and the Regional Harbor Monitoring Program items in his report.

Mr. Wright asked Mr. Robertus if he was still planning on arranging a tour of San Diego Bay. Mr. Robertus said yes.

Mr. Wright urged Board Members to visit the Tijuana Estuary to look at the sedimentation. He said fifteen acres of salt marsh were lost as a result of sedimentation.

Mr. Wright said he would give a copy of the newly published Tijuana River Atlas to any Board Member interested.
