> MINUTES OF MEETING August 10, 2005

## <u>Item 2</u> – Public Forum

Keith Battle, Pala Band Mission Indians, requested a meeting with the Board members to express concerns of the Band for the groundwater quality that might be impacted by the proposed Gregory Canyon Landfill.

Jon Van Rhyn, County of San Diego, spoke about the process of the municipal storm water permit reissuance. Mr. Van Rhyn thanked Regional Board staff for participating in meetings with them and requested the Regional Board hold a forum for the Board to hear the issues presented by the County of San Diego and the co-permittees.

Board Members Wright and Ritschel requested a workshop be held in September.

Andrew Zingale, representing State Assemblymember Lori Saldana, talked about the International Wastewater Treatment Plant and read a letter from Ms. Saldana requesting the Regional Board's response to her proposals concerning the Bajagua LLC project.

## <u>Item 3</u> – Minutes of Board Meeting of June 29, 2005

Mr. Wright moved approval of the June 29, 2005 minutes. The motion was seconded by Mr. Johnson and approved. Ms. Ritschel and Ms. Kraus abstained.

<u>Item 4</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Mr. Wright talked about the 2005 Clean Water Summit that he, Chairman Minan, Mr. Anderson and Mr. Robertus attended and thanked Mr. Robertus for the excellent presentation he gave.

Mr. Johnson talked about the Brownfields issue and pending applications for AB 389. Mr. Johnson asked Mr. Robertus if there was any interest in the program in the San Diego region.

Chairman Minan briefly spoke about the September 19 & 20 WQCC meeting in Sacramento. He also spoke about the CA Biodiversity Council Ocean & Coastal Economic Summit and the Southern CA Wetlands Recovery Project Board of Governors meetings he attended.

Mr. Robertus talked about the City of San Diego River Road Crossing item in his report. He also talked about a meeting he attended with five city managers and representatives from the County of San Diego regarding a Notice of Violation they were issued.

Chairman Minan said he received a letter from Wayne Nastri, U.S. EPA, encouraging the Regional Board to stay on track with regards to the development and implementation of TMDLs.

Chairman Minan asked Mr. Robertus to send a letter of appreciation to Mr. Phillips and Ms. Baczkowski, former supervisors on staff.

Item 5 was removed from the consent calendar and postponed to a future meeting. Ms. Ritschel recused herself from Item 7.

<u>Item 5</u> – Metropolitan Transit System (MTS): Administrative Assessment of Civil Liability against the MTS (formerly known as the Metropolitan Transit Development Board) Violation of SWRCB Order No. 99-08-DWQ, Waste Discharge Requirements for Discharges of Storm Water Runoff Associated with Construction Activity at its Mission Valley East Light Rail Transit Project in San Diego. The Regional Board will consider accepting a proposed settlement in response to Administrative Civil Liability Complaint No. R9-2005-0062. If the Regional Board rejects the settlement, the matter will be rescheduled to a future public hearing at which time the Regional Board will consider assessment of civil liability. If the Regional Board rejects the settlement, the matter will be rescheduled to a future public hearing at which time the Regional Board will consider assessment of civil liability. The Regional Board will consider adoption of an order accepting settlement of the proposed liability in response to Administrative Civil Liability Complaint No. R9-2005-0124. If the Regional Board rejects the settlement, the matter will be rescheduled to a future public hearing at which time the Regional Board will consider assessment of civil liability. Arthur Coe will direct staff presenting evidence and recommendations to the Regional Board, and John Robertus will direct staff advising the Regional Board on these matters.
