Item 2 – Public Forum

Ray Poulter represented the Advanced Group who owns the property encompassing the Forster Canyon Landfill in San Juan Capistrano. Mr. Poulter requested review by staff of the submitted Closure Plan Amendment and Post Closure Maintenance Amendment for the closed landfill site.

<u>Item 3</u> – Minutes of Board Meeting of April 12, 2006

Ms. Ritschel moved approval of the April 12, 2006 minutes. The motion was seconded by Mr. Wright. The minutes were approved with abstention by Mr. Barrett.

<u>Item 4</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Gerald Secundy, State Board Member Liaison, introduced himself to the Board. Mr. Secundy read the bios of the two newest State Board members, Charles Hoppin and Gary Wolff. He also reported on two workshops being held in July on numeric effluent limitations, ex parte communications, ASBS's and 316 B.

Chairman Minan asked Mr. Secundy about the 10% NPDES permit disqualification rules. Mr. Secundy said they would like to try to modify the current rules so that a member would only be disqualified if they received over 10% of their income from an NPDES permit within their particular region, not statewide as it is currently written.

Chairman Minan asked the Board if they would be able to attend the next Board Meeting if the date was changed from August 9 to August 16. All members in attendance said they would be able to attend on August 16. The meeting date was changed to August 16, 2006.

Chairman Minan reported on the June 5th Chair's meeting. The Governor asked for a draft plan on our region's highest priority water quality problems, the measures or targets for them and what would need to be done to achieve the objectives.

Chairman Minan also reported that he attended two judicial proceedings and had speaking engagements at two American Bar Association meetings and one at the Wild Animal Park, all were on water quality issues.

Executive Officer John Robertus spoke about items in his May 10 report which included the Proposed Gregory Canyon Landfill (B-9) and the Paperless Document Management System (B-16).

Chairman Minan asked staff member David Barker questions about the conversion of the Bay Sediment Cleanup records into digital format.

John Richards talked about CEQA documents.

Mr. Robertus continued with his May 10 report, speaking on the Development of Sediment Quality Objectives for California Bays and Estuaries (C-1) and 401 Water Quality Certification Actions (B-2). Mr. Robertus also reported on the Lake Cuyamaca Subsurface Disposal System Status Report (B-10) in his June 14 report.

Board Members asked that an item be put on the agenda to allow the Board to discuss the Lake Cuyamaca Recreation and Park District.

Daniel Johnson asked Mr. Robertus for an update on the soil and lead working group and asked to be kept apprised of the meetings.

Susan Ritschel asked for the status of the region wide Bacteria TMDL process and the reason for the delay. Senior staff member, Ms. Julie Chan gave a status report. Ms. Ritschel asked Ms. Chan to communicate with SAG and to give the Board periodic updates.
