MINUTES OF MEETING AUGUST 8, 2007

At 9:05 a.m. Chairwoman Ritschel called to order the meeting of the California Regional Water Quality Control Board, San Diego Region at the Regional Water Quality Control Board, 9174 Sky Park Court, San Diego, California.

Item 2 – Public Forum

Barbara Daly, Transportation Corridor Agencies, invited the Board on a tour of the final sixteen-mile segment of the State Route 241 - Foothill South Toll Road in Orange County. Chairwoman Ritschel asked Mr. Robertus to set up some potential dates for the tour and arrange access for the public to participate as well.

Gabriel Solmer, Gina Nicholls, and Janet Park from San Diego Coastkeeper spoke about their concerns with delays on the release of the Sediment Shipyard Site cleanup electronic record. They urged Mr. King, the present Hearing Officer, to consider releasing part of the technical report and records that were already indexed and releasing the remainder of the documents as soon as they were indexed. They also requested a detailed bifurcated process proposal.

Board Members and staff discussed the cleanup project. Mr. King said he agreed with the representatives of Coastkeeper and asked that staff release as much information as possible at that time and the rest of the record when it was available.

Senior staff member, David Barker, gave a status report on the Sediment Shipyard Site.

Marco Gonzalez, Coast Law Group, spoke about his concerns with the delays in achieving secondary treatment at the Border.

Item 3 – Minutes of Board Meeting of June 13, 2007

This record of the minutes of the meeting on this date is not intended as the official record of events and is solely for administrative convenience. Mr. Johnson moved approval of the June 13, 2007 minutes. The motion was seconded by Ms. Schneider and approved by unanimous vote.

<u>Item 4</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Chairwoman Ritschel reported that at the August 6th Chair's meeting they discussed the Strategic Plan and the Water Quality Coordinating Committee meeting that is being held in San Diego on October 29 and 30.

Fran Spivy-Weber, State Board liaison, reported on the Natural Resources Defense Council beach report, Statewide Recycled Water Policy, CEQA, ASBS, and the State Board meeting in Los Angeles on October 2.

Board Member Schneider further discussed the NRDC beach report that named Laguna Beach as one of the 13 top cleanest beaches in the U.S. Ms. Schneider credited the NPDES permit process.

Mr. Robertus said he received a letter from San Diego Bay Council indicating their concern over the 316(b) entrainment and impingement issues with the South Bay Power Plant. He also received a similar letter from the Surfrider Foundation on the Encina Power Plant. They were asking if the Board should reopen or pursue action on the power plant permits. Mr. Robertus also reported that a settlement agreement with the City of Escondido on a matter before the Board was petitioned to the State Board and would be heard on September 18.

Consent Item: Item 5 is considered a non-controversial issue. (NOTE: If there is public interest, concern or discussion regarding this consent calendar item or a request for a public hearing, then the item will be removed from the consent calendar and considered after all other agenda items have been completed.)

<u>Item 5</u> – Amendment of Waste Discharge Requirements, County of San Diego, Alpine II Burn Dump, San Diego County (tentative Addendum No. 6 to Order No. 97-11, General Waste Discharge Requirements for Post-Closure Maintenance of Inactive Nonhazardous Waste Landfills Within the San Diego Region) (*Carol Tamaki*)

Mr. Johnson recused himself from voting due to the County of San Diego being a client of his firm.

Item 5 was then postponed due to lack of a quorum.

Remainder of the Agenda (Non-Consent Items):

<u>Item 6</u> – **PUBLIC HEARING**: Conditional Waivers of Waste Discharge Requirements for Specific Types of Discharge within the San Diego Region. The San Diego Water Board will hear testimony and comments on the proposal to amend the Basin Plan to renew and revise conditional waivers, and adopt new conditional waivers for specific types of discharge. The San Diego Water Board will deliberate and consider adoption of an amendment incorporating the revised conditional waivers into the Basin Plan at a subsequent meeting. (Tentative Resolution No. R9-2007-0104) (*Wayne Chiu*)

Mr. Johnson disclosed that he was part of a technical workgroup on one of the waivers being considered but after discussing it with Mr. Richards; felt he did not have a conflict of interest.

Mr. Robertus introduced the item and staff member Wayne Chiu gave the presentation.

Board Member King asked that the scientific data used by staff to make their conclusions be included in the next package sent to the Board.

Mr. Richards explained the purpose of the conditional waivers. Mr. Robertus made closing comments.

Chairwoman Ritschel said she would like to see monitoring start sooner than five years. Mr. Wright concurred.

Ms. Schneider made a motion to continue the item to a future meeting. The motion was seconded by Mr. Johnson and approved by unanimous vote.

<u>Item 7</u> – **PUBLIC HEARING**: Administrative Assessment of Civil Liability against Dakota Ranch Development Co., LLC for violation of its Clean Water Act Section 401 Water Quality Certification issued on January 30, 2003 for the Dakota Ranch Subdivision, Santee, California. The Regional Board will consider whether to raise, lower, or reject assessment of \$140,000 civil liability recommended in Complaint No. R9-2005-0176. (Tentative Order No. R9-2007-0107) (*Frank Melbourn*)

Staff member Frank Melbourn gave the presentation.

<u>Item 8</u> – **PUBLIC HEARING**: Terra Vac, Body Beautiful Car Wash Remediation Dewatering: Administrative Assessment of Civil Liability containing Mandatory Minimum Penalties for reported violations of effluent limitations prescribed in Order No. 2000-90, NPDES No. CAG919001, General Waste Discharge Requirements for Temporary Groundwater Extraction and Similar Waste Discharges to San Diego Bay and Storm Drains or Other Conveyance Systems Tributary Thereto. If the discharger elects to waive their right to a hearing, the Regional Board will consider comments received during the public review period and decide on an order accepting payment of the proposed liability and waiver of hearing. (Tentative Order No. R9-2007-0089) (Rebecca Stewart)

This item was postponed.

<u>Item 9</u> – Consideration of Investigative Order R9-2007-0092 issued on June 1, 2007, to the California Department of Transportation, District 11, and California Transportation Ventures, Inc. The Regional Board will consider the Investigative Order requiring an aerial deposition study to include the Sweetwater Reservoir Airshed to assess impacts on receiving waters from State Route 125. The Regional Board may affirm, modify, or rescind the Investigative Order. (*Christina Arias*)
