MINUTES OF MEETING APRIL 9, 2008

At 9:00 a.m. Chairman Wright called to order the meeting of the California Regional Water Quality Control Board, San Diego Region at the Regional Water Quality Control Board, 9174 Sky Park Court, San Diego, California.

Item 2 – Public Forum

Jim Peugh, San Diego Audubon Society, thanked the Regional Board for releasing the tentative Cleanup and Abatement Order for sediment cleanup in the San Diego shipyard site. Mr. Peugh urged the Board discourage any further delays in the process.

Ms. Krejca, San Diego Coastkeeper, spoke about their concern with the Lane Field Hotel project in Downtown San Diego. Ms. Krejca asked the Board to investigate the soil and ground water contamination at the site.

Ben McCue, Wildcoast, requested that the Board assign a higher priority to the development of TMDLs for the Tijuana River.

Mr. Robertus responded to Mr. McCue's comments and said he would provide more information and the TMDL schedule in his next EO Report.

Item 3 - Minutes of Board Meeting of March 12, 2008

Mr. King moved approval of the March 12, 2008 minutes. The motion was seconded by Mr. Rayfield and approved with abstention by Ms. Schneider.

<u>Item 4</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Chairman Wright reported on topics that were discussed at the Chairs' conference call that he participated in with the State Board and spoke about the April 21 and 22 Water Education Foundation workshop for Board Members.

Mr. Anderson arrived at 9:15 a.m.

Ms. Ritschel spoke about testimony given at the Little Hoover Commission by the Santa Ana Regional Board Executive Officer, Gerald Thibeault. She said his focus was on the facilitated public process that his region utilized with higher profile policy development decisions such as Basin Plan amendments, etc. Ms. Ritschel said she would like Mr. Robertus and Chairman Wright (or herself) to meet with Mr. Thibeault and his Regional Board Chair to learn about their facilitated process. Mr. Robertus said he would schedule the meeting.

Mr. Anderson complemented the City of Oceanside on an informative agricultural waivers workshop that was held on March 27.

Mr. King reported on the status of the San Diego Bay Sediment Cleanup process. He reported on April 4 that the digital copy of the entire administrative record was released. Mr. King also announced that a pre-hearing conference would be held on April 25.

Mr. Robertus reported on the four party lawsuit between Camp Pendleton, Fallbrook, and Eastern Municipal Water Districts, and the Rancho California Water District. He also reported on the Federal court lawsuit against the International Boundary and Water Commission.

<u>Item 5</u> – Resolution to Request Funding from the Clean up and Abatement Account: Sediment contamination and eutrophication in coastal wetlands in the San Diego region. (Tentative Resolution No. R9-2008-0029) (*Lilian Busse*)

Mr. King made a motion to approve Resolution No. R9-2008-0029. The motion was seconded by Ms. Ritschel and approved by unanimous vote.

The San Diego Water Board will deliberate on and consider adoption of an amendment incorporating the TMDLS into the Basin Plan at a subsequent meeting. An errata was prepared by staff and distributed to the Board. Mr. Anderson recommended a change to the errata that would address a concern made by Mr. Garrett.

After Board Member discussion, Mr. King made a motion to approve the errata, with the word "Consensus" being changed to "Coordination" and adding the language "...as required by Section 13225 of the California Water Code" in 3.c. The word "Appropriateness" was changed to "Adequacy" in 3.d. The motion was seconded by Ms. Schneider and approved by unanimous vote.

Ms. Schneider made a motion to conditionally adopt Resolution No. R9-2008-0039 with the amended errata. The motion was seconded by Mr. Anderson. The motion carried 5-2, with opposition by Mr. Wright and Mr. Rayfield.
