Mr. Thompson moved approval of the January 21, 2009 minutes. The motion was seconded by Mr. Rayfield and approved by unanimous vote.

Chairman Wright announced that Item 4 would be heard later in the meeting. He also announced that Item 10 would be heard after Item 5 and that Items 8, 11, and 12 were postponed.

Consent Item:

Item 5 – Administrative Assessment of Civil Liability, Studio 15 Housing Partners, Studio 15 Construction Dewatering. The Regional Board will consider adoption of a tentative Order that would impose a \$42,000 mandatory minimum penalty recommended in Amended Complaint R9-2008-0121 for violations of effluent limitations prescribed in Order 2000-90, NPDES No. CAG919001, General Waste Discharge Requirements for Temporary Groundwater Extraction and Similar Waste Discharges to San Diego Bay and Storm Drains or Other Conveyance Systems Tributary Thereto. The Regional Board may approve, modify, or reject assessment of the recommended penalty. If the Regional Board rejects the tentative Order, the matter will be rescheduled to a future public hearing at which time the Regional Board will consider assessment of civil liability. (Tentative Order R9-2009-0022) (Frank Melbourn)

A motion was made by Mr. Rayfield to approve Order R9-2009-0022. The motion was seconded by Mr. Destache and approved by unanimous vote.

Remainder of the Agenda (Non-Consent Items):

Item 10 – Administrative Assessment of Civil Liability, America Plaza Owners Association, One America Plaza Dewatering. The Regional Board will consider adoption of a tentative Order that would impose \$12,000 in civil liability recommended in Complaint R9-2008-0127 for violations of effluent limitations prescribed in Order 2000-90, NPDES No. CAG919001, General Waste Discharge Requirements for Temporary Groundwater Extraction and Similar Waste Discharges to San Diego Bay and Storm Drains or Other Conveyance Systems Tributary Thereto. The Regional Board may approve, modify, or reject assessment of the recommended penalty. (Tentative Order R9-2009-0019) (Rebecca Stewart)

Staff member Rebecca Stewart gave a brief presentation.

A motion was made by Mr. Rayfield to approve Order R9-2009-0019. The motion was seconded by Mr. Weber and approved by unanimous vote.

<u>Item 6</u> – Poseidon Resources Corporation, Proposed Carlsbad Desalination Project (Order No. R9-2006-0065, NPDES No. CA0109223). The Regional Board will consider whether the Marine Life Mitigation Plan (MLMP) dated November 14, 2008, satisfies the conditions established in Resolution No. R9-2008-0039, Conditional Approval of Revised Flow, Entrainment, and Impingement Minimization Plan for Poseidon Resources Corporation Carlsbad Desalination Project (Resolution), or whether failure to satisfy the conditions has rendered the Resolution inoperative by its own terms. The Regional Board may also provide direction to staff concerning future actions related to this Project. (*Michelle Mata*)

The Regional Board directs staff to work with Poseidon to expeditiously address the list of outstanding issues identified by Mr. Robertus and further directs staff to prepare for Board consideration a resolution or order approving the Flow, Entrainment, and Impingement Minimization Plan required by the NPDES Permit issued to Poseidon in 2006. Finally, the Board directs that the public notice for this item make clear that it is not necessary to resubmit written comments that are already in the record or to repeat oral statements already made and included in the record at that time."

Mr. Rayfield amended his motion to accept the recommendation made by Ms. Hagan. The motion was seconded by Mr. Loveland and approved by unanimous vote.

The meeting was recessed for Closed Session and lunch at 1:10 p.m.

After Board Member discussion, a motion was made by Mr. Loveland to approve R9-2009-000. The motion was seconded by Mr. Thompson and approved by a 4-3 vote. Mr. Wright, Mr. Destache, and Mr. Rayfield were in opposition.

<u>Item 8</u> – NPDES Permit Revision: Dynegy South Bay, LLC, South Bay Power Plant wastewater discharge to the San Diego Bay, San Diego County, Order No. R9-2004-0154, NPDES No. CA0001368 (Order). The Regional Board will consider revising the effluent limitations for copper using a new translator and revising monitoring requirements contained in the Order. Today's action is limited to the portions of Order No. R9-2004-0154 specified in the proposed revisions. No other portions of the Order are being considered for revision at this time. (Tentative Resolution No. R9-2009-0006) (*Vicente Rodriguez*)

Item 8 was postponed.

<u>Item 9</u> – A public hearing will be held to consider the issuance of Tentative Cleanup and Abatement Order (CAO) No. R9-2008-0152. The proposed CAO would be issued to Dr. William & Lori Moritz for the alleged unauthorized discharge of fill to an unnamed, ephemeral stream that is tributary to Rattlesnake Creek and ultimately Poway Creek in violation of Sections 13260(a) and 13264(a) of the California Water Code, and waste discharge prohibitions 1, 3, and 14 contained in the in the Water Quality Control Plan for the San Diego Basin. (Christopher Means)

Chairman Wright read the hearing procedures. Mr. Jorge Leoń gave an opening statement. Staff member Christopher Means gave the presentation.

Mr. Douglas Simpson, The Simpson Law Firm, cross-examined Mr. Means.

Mr. Leoń gave a brief presentation.

Mr. Simpson also gave a presentation. Mr. Simpson then called Mrs. Lori Moritz and Mr. William Moritz to the podium for questioning.

Mr. Simpson made closing statements.

Mr. Leoń made closing statements.

Mr. Robertus recommended adoption of the Cleanup and Abatement Order.

Board Members made comments.

Board Member Destache made a motion to adopt Order No. R9-2008-0152. The motion was seconded by Mr. Weber and approved by unanimous vote.

<u>Item 11</u> – Master Reclamation Permit with Waste Discharge Requirements for the United States Marine Corps: Discharges of Reclaimed Water for Landscape Irrigation at Marine Corps Base Camp Pendleton, California (Tentative Order No. R9-2009-0021) (Robert Pierce)

Item 11 was postponed.

<u>Item 12</u> – Administrative Assessment of Civil Liability, Ametek Inc., Former Ametek/Ketema Aerospace Manufacturing Facility, 790 Greenfield Drive, El Cajon, California. The Regional Board will consider adoption of a tentative Order that would impose a \$2,269,000 penalty recommended in Complaint No. R9-2008-0033 for the alleged violations of Cleanup and Abatement Order No. R9-2002-0201. The Regional Board may approve, modify, or reject assessment of the recommended penalty. (Tentative Order No. R9-2009-0024) (Laurie Walsh/John Anderson)

<u>Item 4</u> – Chairman's, Board Members', State Board liaison's and Executive Officer's Reports: These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

Mr. Robertus reminded the Board Members about the Water Quality Coordinating Committee meeting being held in Chino Hills on February 23 & 24, 2009.

Ms. Hagan talked about a section in the Water Code that says a hearing panel of three or more Board Members could hear certain types of matters that came before the Board, receive evidence, and then the panel would then make a proposed decision that they would recommend to the full Board. The full Board would then make a final decision on the action. She said the Advisory Team was considering this process for an administrative civil liability case with Ametek, Inc. and gave detailed information on the process. Chairman Wright said he thought it was a good idea. The Board Members agreed that the full Board should be involved in selecting the hearing panel. Ms. Hagan said an item could be scheduled for the March 11 agenda to allow for Board discussion on the process and possible panel selection. Mr. John Lormon – Procopio, Cory, Hargreaves, & Savitch – represented Ametek and said he wanted the full Board hearing to be held no later than April 8, 2009.
