> MINUTES OF MEETING JUNE 26, 2014

At 9:00 a.m., Chairman Abarbanel called to order the meeting of the California Regional Water Quality Control Board, San Diego Region (SDRWQCB) at the Regional Water Quality Control Board, 2375 Northside Drive, San Diego, California.

### Item 1 - Roll Call and Introductions

#### **Item 2** – Public Forum

The Board directed the Executive Officer to schedule this discussion as an information item at a future Board meeting and to convene a working group consisting of homeowners, stakeholders, and the Department of Toxic Substances Control (DTSC) to advance the discussion. This discussion may result in an action item to be brought before the Board.

Item 3 – Minutes of Board Meetings: May 14, 2014; May 27, 2014

Mr. Anderson moved to adopt the minutes, and Mr. Strawn seconded the motion. Dr. Abarbanel and Mr. Morales abstained from voting on the minutes from May 27, 2014, as they did not attend the meeting. Both sets of minutes were approved by unanimous vote by those who participated in each meeting.

<u>Item 4</u> – Chairman's, Board Members', State Water Board liaison's, and Executive Officer's Reports. These items are for Board discussion only. No public testimony will be allowed, and the Board will take no formal action.

The State Water Board liaison was not present.

Mr. Gibson announced that the new State budget had been passed by the legislature and signed by the Governor. Mr. Gibson also introduced new staff members and announced that Chad Loflen had been promoted to Senior Environmental Scientist. In addition, he stated that the Budget Change Proposal (BCP) for an international border liaison has received initial approval, and that Region 9 would share that position with Region 7 if it receives final approval for fiscal year 2015-2016. Finally, Mr. Gibson stated that he would be attending a meeting of the full Tijuana River Valley Recovery Team on August 27 and an Alternative Compliance Options Forum on July 17.

Dr. Abarbanel reported on the Board's evaluation of Mr. Gibson's performance as Executive Officer and their recommendations to the State Board based on that performance evaluation.

<u>Item 8</u> – Future Agenda Items: Board Members may discuss items for possible inclusion on future agendas. No action will be taken. (*David Gibson*)

Dr. Abarbanel took Item 8 out of order, and Mr. Morales asked for periodic updates regarding staff's activities on behalf of the Board regarding environmental justice. In response to that request, Ms. Kalemkiarian provided an update on her meeting with staff on May 15 seeking suggestions for community outreach activities.
