MINUTES OF MEETING NOVEMBER 9, 2016

At 9:00 a.m., Chairman Abarbanel called to order the meeting of the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) at the Board Meeting Room, 2375 Northside Drive, Suite 108, San Diego, California.

Penny Elia addressed the Board regarding a potential water quality issue related to an approved single family construction project in Laguna Beach.

Minutes of Meeting November 9, 2016

Luis Perez from the Navy spoke about the Naval Base Point Loma's SWIM program to address environmental concerns and responded to Board Member questions.

Kimberly McMurray Cathcart and Lucas Lima gave a presentation regarding a trash cleanup program in Curitiba, Brazil and responded to Board Member questions and suggestions.

<u>Item 3</u> – Minutes of Board Meeting: October 12, 2016:

Dr. Olson moved to approve the minutes, and Chair Abarbanel seconded the motion. A roll call vote was taken, and Board Members Abarbanel, Morales, Olson, Strawn, and Warren voted "aye." The motion passed.

Chair Abarbanel provided an update on Outreach meetings convened with NGOs in Orange County.

Mr. Gibson reported that a meeting of the Tijuana River Valley Recovery Team will be convened in January and responded to Board Member questions. In addition, Brandi Outwin-Beals responded to Board Member questions.

Ms. Warren asked for an update on the plume near Magnolia School in El Cajon, and Dr. Olson asked for an update on the algal blooms in local water bodies.

Dr. Olson moved to approve the 2017 Meeting Schedule, and Mr. Morales seconded the motion. A roll call vote was taken, and Board Members Abarbanel, Morales, Olson, Strawn, and Warren voted "aye." The motion passed.

<u>Item 7</u> – Rescission of WDRs: Valley View Dairy, San Diego County. (Roger Mitchell)

Mr. Morales moved to approve the Consent Calendar, and Dr. Olson seconded the motion. A roll call vote was taken, and Board Members Abarbanel, Morales, Olson, Strawn, and Warren voted "aye." The motion passed.

Chair Abarbanel called a recess at 10:05 a.m., and reconvened the meeting at 10:27 a.m.
