- Eric Larsen, Farmers Association, updated the Board on Commercial Ag Program enrollments.
- Craig Barilotti and Norman Allenby, addressed the Board regarding improvements to Sunset Cliffs park.
- Dan McKirnan, EHC, provided further interpretation of the Fish Consumption Study results.
- Ms. Jitka Parez commented on the Linden Road item, and
   Ms. Ryan and Ms. Hagan responded to Board Member questions.
- Paul Warren addressed the Board regarding concerns with board interaction regarding his property after the Chair granted his request to reopen Public Forum at approximately 11:30 a.m.

Chair Abarbanel provided a report on various discussions and meetings held among himself, Mr. Gibson, their counterparts from the San Francisco Region, and representatives from San Diego County and City regarding next generation monitoring solutions.

Mr. Gibson thanked Barry Pulver for his service, announcing that Mr. Pulver had retired on October 31, 2017, and he announced that Christina Arias had been selected to take over Mr. Pulver's position. In addition, he announced that Fisayo Osibodu had been selected to serve in the Source Control Unit, and he welcomed Regan Morey, Water Resource Control Engineer, to the Storm Water Unit.

Mr. Gibson also provided a summary of a meeting the day before organized by the Department of Justice to discuss a lawsuit regarding cross-boundary flows with the International Boundary and Water Commission and other stakeholders.

He then invited Brian Hitchens from Geosyntec to address the Board regarding TDY's San Diego Bay sediment cleanup operations.
