The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) will hold two public workshops on the renewal of Order No. R9-2019-0005, Conditional Waivers of Waste Discharge Requirements for Low Threat Discharges in the San Diego Region (Conditional Waivers). California Water Code section 13269(a)(1) provides the San Diego Water Board with the authority to waive waste discharge requirements for specific types of waste discharge, which are a low threat to surface waters and groundwaters throughout the San Diego Region.

The purpose of the public workshop is for the San Diego Water Board to discuss proposed changes to the Conditional Waivers and receive informal comments from stakeholders and interested members of the public. The San Diego Water Board will consider the comments and information received during the public workshops while considering revisions to the Conditional Waivers. The San Diego Water Board anticipates releasing the revised Conditional Waivers for formal public review and comment in the spring of 2024.
