**IN THE MATTER OF BOSA DEVELOPMENT CALIFORNIA II, INC.
GROUNDWATER EXTRACTION DISCHARGE TO SURFACE WATERS WITHIN THE
SAN DIEGO REGION**

TENTATIVE ORDER

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is considering the adoption of Settlement Agreement and Stipulation for Entry of Administrative Civil Liability Order (Stipulated Order) No. R9-2018-0177. The Stipulated Order is a settlement agreement between Bosa Development California II, Inc. and the San Diego Water Board's Prosecution Team to address the mandatory minimum penalty associated with an alleged late reporting violation of *General Waste Discharge Requirements for Groundwater Extraction Discharges to Surface Waters within the San Diego Region* (Order No. R9-2015-0013).

To resolve the alleged violation without formal administrative proceedings, Bosa Development California II, Inc. has agreed to the final imposition of an administrative civil liability in the amount of \$15,000, the mandatory minimum penalty amount required by Water Code section 13385.1.
